

Phase	Description	
Normal	Normal operations	
Alpha	Normal operations	
Bravo	Full operations in ALERT mode	
Charly	Full operations in ALARM mode	
Delta	Contingency mode	
Echo	Hibernation mode	
Foxtrot	Standstill	

Main features

No particular measures required

General recommendations for hygiene, health and safety, guidance for travelers

Increased hygiene level (dispensers at certain locations, cleaning/sanitization of surfaces)

Checks at gates, WFH, virtual meetings, stop full service canteens

Prioritize activities, e.g. manufacturing of critical products

Only maintain infrastructure, tank farms, ventilation, security. Prepare for total standstill.

Total standstill without maintaining infrastructure

When to declare

Dec 2019: No indication of pandemic situation

Jan 2020: First indication that pandemic may be developing.

Feb 2020: First infections within city limits or many cases in state.

March 2020: Beginning of infections in nearby localities

March 24, 2020: Government Lockdown

Restricted manpower availability

// Positive COVID-19 case onsite

Complete lockdown in containment zone.

Hierarchy of Control at manufacturing sites



- Postpone non-critical tasks
- Work from home

Substitution

• Physical distancing > 2m

Engineering Contro

- Structural adjustments
- Non contact operation
- Shift duration/timings

Administrative Control

- Site entry screening
- Enhanced housekeeping/ hygiene
- Medical evaluations

Personal Protective Equipment (PPE)

 Surgical mask (work <2 metre distance and > 15m interval). Maintain register of contacts.

Comprehensive screening prior to restart work

Sr.	Question	Confirmation
1	I confirm that I or my family member(s) are not currently experiencing any of the following symptoms - body temperature > 100F, dry cough, fever, difficulty in breathing, loss of taste or smell, muscle aches, abdominal pain, diarrhoea, headache or any flu-like symptom	Yes/ No
2	I confirm that I or my family member(s) have not been diagnosed / treated or recovering from COVID-19 or put in government quarantine in past 30 days	Yes/ No
3	I confirm that I am not in contact with a COVID-19 confirmed or suspected case in last 14 days	Yes/ No
4	I confirm that I am not residing in any active containment area.	Yes/ No
5	I will strictly follow all Government and Company norms on social distancing, use of masks and hygiene in public areas, commute and work	Yes/ No
6	I have gone through and understood this back-to-office advisory training on COVID-19	Yes/ No
7	I undertake to communicate to my manager/ site services/ HSE if there is any change in any of my reply above immediately	Yes/ No





