From the Secretary General's Desk...

here is little doubt that the digital revolution now stands at the cusp of a transformation, with the government having laid out its vision of a digitally enabled India over the last one year. The success of both 'Digital India' and 'Make in India' programmes envisioned by the Government of India and embraced by the people, will ride on the back of a strong telecom ecosystem, digital infrastructure and industry's link in the value chain.

In this backdrop, FICCI, in association with the Department of Telecommunications, Ministry of Communications & IT, Government of India, organised 'Digital Bharat 2015' in New Delhi last month, the maiden edition of FICCI's 'Digital Bharat', a platform for transformative exchanges and deliberations.

In a whiff of fresh air, Ravi Shankar Prasad, Union Minister for Communications & IT, who inaugurated the event assured industry that the auction of spectrum in the future too would be conducted in a timely, fair and transparent way. The hallmark will be good governance and "the road map will be fully disclosed in advance so that industry can put its act together in a planned manner." We bring to you a report in this issue.

We also bring to you perspectives by two CEOs on 'Smart Cities', one by Harshavardhan Neotia of Ambuja Neotia Group and Senior Vice President of FICCI and Hari Sankaran of IL&FS. Additionally, we carry a report on how Location Based Services (LBS) can transform the Indian landscape. According to a FICCI-PwC report, in order to mitigate challenges and ensure effective implementation of LBS along with smart city components across cities, there is a need to use LBS during assessment of city master planning; create a single agency for generating, collecting and utilising location and geospatial data of a city and frame a policy for data security and privacy.

The New Government at the Centre led by Narendra Modi completed one year in office last month. FICCI unveiled a comprehensive report card on the Government's one year in office. At a media conference, Dr. Jyotsna Suri, President of FICCI, said, "The main achievement of the government in the past year is the creation of a positive business sentiment, restoration of investor confidence and establishment of 'Brand India', by framing policies that rest on transparency and fairness."

It was observed that no government at the Centre has worked so hard in one year to reverse the spiral of negativity and brought in policies that will spur demand and growth in the very near future. FICCI, however, believes that the government should now focus on raising farm productivity and formulate a water policy that ensures efficient and fair distribution of water for agriculture, industrial and domestic consumption.

Terming the government's pro-industry label as "pure rhetoric", Dr. Suri said that without growth, it would be impossible to provide jobs to the 23 million young people who descend in the job market every month. The slowing down of rural and urban demand was a cause for concern, she said and added that government spending on infrastructure projects must rise significantly to fuel the industrial economy. The challenge posed by the proposed mega-regional trade pact - the Trans-Pacific Partnership (TPP) - will impact India's exports significantly and the country would do well to make a concerted all-round effort to prepare for and undertake domestic market reform and push for not just export of manufactures but also of services and agricultural products. This word of caution by Suresh Prabhu, Union Minister for Railways, merits attention by policy makers and industry alike.

Prabhu's advice came at the conference on 'Changing Global Economic Scenario: Implications for India's Trade Policy and Make in India Programme', organised jointly by FICCI, International Institute for Sustainable Development (IISD) and Centre for WTO Studies. In the emerging global economic environment, domestic reforms would be the key to improving product standards, manufacturing and services delivery. Such an approach was vital to remain competitive in the global markets as the US was fast tracking the finalisation of TPP.
