From the Secretary General

February 2019 was a month full of events for us at FICCI and we have captured their essence in this issue of *Business Digest*.

The summit organised by the Government of West Bengal with FICCI as its Summit Partner was held in Kolkata this month. The Chief Minister of West Bengal, Mamata Banerjee, inaugurated the summit. Amit Mitra, Finance and Industries Minister of West Bengal was also present at the inaugural session. Industry doyens including Mukesh Ambani, Sajjan Jindal, and Sanjiv Goenka and several FICCI Past President, namely, Rajan Bharti Mittal, Vice Chairman, Bharti Enterprises Ltd., YK Modi, Executive Chairman, Great Eastern Energy Corporation Ltd., Harshavardhan Neotia, Chairman, Ambuja Neotia Group, Saroj Kumar Poddar, Chairman, Adventz Group and Siddharth Birla, Chairman, Xpro India Limited joined in.

In New Delhi, the 4th India ASEAN Expo and Summit of Trade Ministers saw FICCI put its best foot forward by hosting this important meet where trade ministers and ambassadors and their delegations from 10 countries came together to help chalk out a roadmap to improve India-ASEAN economic relations. While Minister Suresh Prabhu addressed the inaugural session and Home Minister Rajnath Singh gave the valedictory address. FICCI President Sandip Somany highlighted Prime Minister Narendra Modi's SAGAR initiative in this context and the government's continued Look East Policy.

At the National Conclave on Technical Textiles and Curtain-raiser for Technotex 2019, Smriti Zubin Irani, Union Minister of Textiles, released a booklet on HS Codes for 207 technical textiles items and addressed the delegates.

Shashi Tharoor, Member of Parliament & Chairman of the Parliamentary Standing Committee on External Affairs, emphasized the efficacy of soft power of culture during the Smart Cities, Art Cities Summit. He appreciated FICCI's efforts in organising this 'valuable' initiative and elaborated that soft power can propel cities into the global cultural map, promote people-to-people contact, give a fillip to allied industries such as tourism and build smart infrastructure.

Union Minister Harsh Vardhan at the 6th DST-FICCI Global R&D Summit 2019, held in Hyderabad, emphasized that in year 2018 country's research and development with technology led innovation got further recognition as one of the most powerful instruments of growth and development.
