FICCI organized a 'Knowledge Series on GST' with special reference to annual returns and recent amendments, on January 16, 2019 at Hotel Park Grand, Chandigarh.

The initiative enhanced industry's understanding of the latest developments in GST and provided them a field to raise their issues with relevant government authority. Mr. Sanjay Malhotra, Practicing Company Secretary and Convener, FICCI Regional Taxation Committee led the participants through the intricacies of GSTR9 & GSTR9C. Key officials from Central Goods and Services Tax Commissionerate-Chandigarh, including Ms. Manoranjan Kaur Virk, IRS, Chief Commissioner; Mr. Kishori Lal, IRS, Commissioner; Mr. K.G Dhawan, IRS, Additional Commissioner; Mr. Rajan Datt, IRS, Additional Commissioner-CCU and Mr. Balbir Singh Khaira, IRS, Assistant Commissioner- GST & NACEN, Chandigarh pointed to the training programs, Seva-Kendra and special refund drives to make GST process easier for tax-payers and offered complete support to resolve industry's concerns.

# Day 2

Following up with the intellectually charged sessions of Day 1, Day 2 encompassed discussion over E-Waste and Construction & Demolition Waste Management Rules, 2016. Speakers from MoEFCC, Karo Sambhav Private Limited (E-Waste PRO) and IL&FS Environmental Infrastructure and Service unequivocally supported data-based policies for benefit of recyclers. Lack of information on reverse logistics company was also identified and MoEFCC was requested to come up with notifications and consider a mechanism where it could map and release list of PRO companies.

# REGIONAL STAKEHOLDERS CONSULTATION ON WASTE MANAGEMENT RULES, 2016

#### January 21-22, 2019 | Chandigarh

Federation of Indian Chamber of Commerce and Industry (FICCI) in association with Ministry of Environment, Forest and Climate Change (MoEFCC) organized a two-day consultation with regional stakeholders on waste-management rules 2016 on January 21-22, 2019 in Chandigarh.

The Waste Management Rules, 2016 (Municipal Solid Waste, E-waste, Construction & Demolition Waste and Plastic Waste) were notified and amended by MoEFCC. This Consultation highlighted learnings from best practices and success stories in waste management to draw a roapmap of practical measures for effective implementation of these rules. More than 130 industry members participated in focused sessions on Solid Waste and Plastic Waste Management Rules, and E-Waste and Construction & Demolition Waste Management Rules, 2016 on Day 1 and 2 respectively.

A site-visit to a Dadu Majra Waste Processing plant in Chandigarh was also arranged to provide practical knowledge of the waste handling process and received active interest from the attendees.



# INTERACTIVE SESSION ON 'ENVISIONING INDIA 2030'

February 13, 2019 | NITTTR, Chandigarh; February 14, 2019 | IIT Ropar

FICCI Regional Advisory Council- Chandigarh organized an interactive session on Envisioning India 2030' on February 13, 2019 at NITTR, Chandigarh.

FICCI released its vision document 'Envisioning India 2030' in December last year enlisting agendas and reforms to enable India reach its goal of shared prosperity by the year 2030. The document covered 10 inter-related sectors, planned intervention wherein can make India a \$9-10 trillion economy. This interaction session aimed at capturing the perspective of the stakeholders on the suggested reforms, and in the process, strengthening the action plan specific to North Indian States. More than 50 representatives from the industry, academia and research institutes participated in it.

Mr. Subodh Aggarwal, Advisor-FICCI set the tone of the session and pointed to the tremendous growth potential for India in renewable energy and organic farming. Dr. Ajay Chhibber, Chief Economic Advisor- FICCI extensively discussed the document and summarized with three broad heads

- Shift from Hand-Outs to Hand-Ups Focusing on investment than on subsidies and money handouts
- Reboot Reforms 2.0 Need of another wave of agricultural and industrial reforms
- Change in Balance Sheet of State Quicker resolution of Non-Performing Assets, leveraging on insurance & pension, and increasing genuine financial inclusion

The second edition of the interactive session was organized by FICCI in IIT Ropar on February 14, 2019. Similar proceedings were followed by an interaction between Dr. Chhibber and the students.

"Industries consume about 47% of India's energy supply, which is a big

chunk of energy going into industries. If we convert it in terms of industrial expenditure, energy would form about 22% of industries overall spending."

other policy measures to reduce industrial energy emission. Col Sumeet Malhan, CTOO, PRESPL emphasized the significance of waste-to-energy technologies in his presentation on biomass. The Government released a Public Procurement Policy in 2012, that earmarks 25% procurement of government-run agencies from MSME, and further sets a sub-target of 4% procurement from SC/ST Entrepreneurs. Mr. Ravi Kant (Head NSSHO, NSIC), Mr. Rakesh Vaid (Assistant Director, MSME Development Institute, Ludhiana) and Mr. Kush Tyagi (Business Facilitator, Government e-Marketplace) and graced the meet as speakers.

More than ten buyers, including Punjab State Warehousing Corporation, BPCL, HPCL, VERKA, Punja b Agro Industries, Rural Electrification Corporation Limited, ECGC Limited, National Fertilizer Limited, interacted with 60+ number of MSME SC/ST sellers to share details on their procurement and vendor registration in a one-to-one interaction session.
