Key Developments

IPGMER set to be the first govt Hosp to take up lung transplant.

IPGMER is now set for its first lung transplant — also a first in a govt hospital in Bengal. This would be Bengal's third lung transplant. The other two had taken place at Medica Superspecialty Hospital. IPGMER (SSKM), the only hospital in the govt sector to have lung transplant facility in Bengal, had got the licence for lung transplant five years ago. The hospital had sent its transplant team to various training and workshops. Its maiden lung transplant will be conducted on a 56-year-old man who has been battling lung failure. The surgery will be done by the trained team from cardiothoracic and vascular surgery department.

Kol firm joins hands with AP for e-waste recycling.

As part of the partnership, Eyantram is set to unveil its first integrated recycling plant in Visakhapatnam at an investment of Rs 15-20 crore. Eyantram is Webel's e-waste recycling partner and has a facility at South 24 Parganas' Bakrahat. Land has already been acquired for the plant at Visakhapatnam and construction work will start after some clearances. The plant will be equipped with modern technologies needed for e-waste recycling. The firm plans to use this facility for recycling e-waste collected from Bengal and parts of eastern India.

CESC buys solar park developer.

CESC Ltd this week said one of its step-down subsidiaries, Purvah Green Power, has completed the acquisition of the 100 per cent stake in Bhadla Three SKP Green Ventures, that is in the process of developing a 300-MW solar park in Rajasthan. The acquisition will bolster the renewable energy portfolio of the power utility. The power utility said the acquired company is developing a solar park with a capacity of 300 MW in Phalodi district of Rajasthan, and its operations are entirely based in India. The target company has not yet generated any revenue, as its project is still under development. However, it has obtained the necessary approval from the central transmission unit for interstate evacuation of solar power with a capacity of 300 MW and has partially acquired land.

Two start-ups by two city youths have received official clearances from the state government to start their operations covering Calcutta and its adjoining areas involving two-wheelers. BiGo, a joint initiative by city-born Ankit Nevadia and Ankit Jalan, is offering two-wheelers with drivers on rent. The other, Radhashree Roadstars by Raghav Randar, offers bikes

for rent, without drivers. The first is aimed at meeting office errands, including visiting banks, delivering packages, dropping by construction sites and picking up clients for meetings. The other venture by Randar revolves around renting out bikes to those who want to go out on short staycations to places in and around Calcutta and for the more adventurous ones, to other parts of the state including the hills, rivers, jungles and the sea.
