1. COURSE OBJECTIVE

- Techniques for the identification of environmental aspects ranging from risk assessment methodologies, life cycle analysis, emission analysis, identification of significant releases.
- Assess the degree of control of environmental impacts within an organisation and how to evaluate the effectiveness of these measures.

- Environmental legislations and international treaties, conventions and charters.
- Assessing the programmes and delivery of internal EMS auditing within an organisation and investigating the management review of the system.
- The EMS Auditing Process including exercises and examples of documents and other evidence, which reveals the effectiveness of the EMS.
- Understanding the roles of national, international bodies, certifies and auditors in the certification of EMS.

Note: The course methodology includes a series of formal presentations, case studies, syndicate group exercises and extensive role play activities on real life situations.

5. RECOGNITION

The course is certificated with the IRCA -UK (International Register of Certificated Auditors) as an approved EMS Auditor/Lead Auditor Course (Course Registration No. A17479). The course meets the training requirements for individuals seeking registration as Auditors/Lead Auditor with IRCA.
