We also look forward to innovative partnerships to avail in a sustainable

manner of business opportunities that lie in the ocean that binds us all, the

Indian Ocean.

To conclude, I would like to urge both public and private sector

representatives assembled here today, to come up with proposals that will

lay the firm foundation for fruitful cooperation between the Government and

the business community in the attainment of our common objective for

inclusive and sustainable development.
