- You wish to become registered as OHSMS Auditor or Lead Auditor with International Register of Certificated Auditors (IRCA - UK)

3. PREREQUISITE

Prior to commencement of the course, participants are expected to have an understanding of the content & implementation of OHSAS 18001 international standard.

4. RECOGNITION

The course is recognized by the IRCA, UK (International Register of Certificated Auditors). The course meets the training requirements for individuals seeking registration as OHSMS Auditors/Lead Auditor with IRCA. The course bears IRCA Certification No. A 17357

5. COURSE MATERIAL

Registered participants are sent pre-course exercise material in advance along with OHSAS 18001 standard for their study. Course kit comprising detailed course material, handouts and audit exercises is given during the training to each participant.

6. CERTIFICATE

Those participants who successfully complete the continuous assessment during the course and also the written examination, which is conducted on 5th day of the course, **will be issued certificate by Nigel Bauer & Associates, UK.**
