Overview


rop Protection chemicals are recognized as an essential input for increasing agricultural production and preventing crop loss before and after harvesting. Indian Crop Protection Chemicals Industry has contributed significantly towards increased agriculture output and ensuring national food security. Besides catering to domestic requirements, the sector is also export oriented and makes substantial exports even to the developed countries.

French Institute of Demographic Studies, predicts that by 2050, India will take the top spot with a staggering population of 1.6 billion (up from the present level of 1.2 billion) to leave behind current world leader China at the second place with 1.3 billion people. India requires a robust modernized agriculture to ensure the food and nutrition security for its population. Scope for further increasing cultivable land is limited. In order to meet the food grain requirements of the nation the agricultural productivity and its growth need to be sustained and further improved. Crop Protection Chemicals are here to stay, but the nature of the industry could be very different in the next decade!


There is huge unrealized potential of growth of this sector, looking at presently very low consumption compared to the global levels. It shows significant growth opportunities.

Besides increasing in domestic consumption, the exports by the Indian Crop Protection Chemicals Industry can be doubled in the next five years if proper strategies and sophisticated technologies are adopted by the industry.


