Madrid etc.", remarked Mr. Elias George IAS, Additional Chief Secretary, Transport, Govt. of Kerala and also Managing Director, Kochi Metro Rail Limited in his Key Note Address at the Federation of Indian Chambers of Commerce & Industry (FICCI) Kerala State Council Annual Meet 2014. "The time has now come to move towards branding specific locales in Kerala for tourism and investment promotion. Kerala is becoming a global brand for Tourism, Physical attributes: greenery, backwaters & hills, equitable quality of life and health care," said Additional Chief Secretary, Transport, Govt. of Kerala.
