To commemorate its Golden Jubilee, the Indian Council of Arbitration (ICA), the premier arbitral body of India, is organizing, with the support of FICCI, an International Conference on "Arbitration in the Era of Globalization" on 11th & 12th December, 2015 at New Delhi.
