Mr V S Krishnan, Member (Service Tax), Central Board of Excise and Customs (CBEC) said the draft Goods and Service Tax (GST) law prepared by the Central Board of Excise and Customs (CBEC) in consultation with State governments is ready, and will soon be given to the GST Empowered Committee of State Finance Ministers for ratification. He said the GST offers a unique opportunity to create a 'world-class' indirect tax system. He said however a dispute resolution needs to be fixed.





We need a central clarification authority to interpret the law. We take too much time in adjudication, like in refunds. We in the CBEC are seriously looking at changing the dispute resolution system.

"Asked about the revenue-neutral rate (RNR — the rate at which the government receives the same amount of money despite changes in tax laws) for GST". He said the Empowered Committee has directed the National Institute of Public Finance and Policy (NIPFP) to undertake a study on the revenue implication of GST and estimation of RNR. The NIPFP is likely to submit its report soon

He said The Centre has also set up a committee under the Chief Economic Advisor to look at the RNR in a dynamic way. This group is expected to submit its report by October-end.
