Brief Overview

- Around 70 lakh private security personnel are currently engaged in securing assets and protecting lives across India.
- Estimated 6 million people employed, mostly rural migrants aged between 19 and 35 years
- Large contribution to exchequer by service tax, PF, etc
- Has potential to be second highest employment generator in the country
- Organised players account for about 25% of the sector (domestic & international)
- Industry is regulated by Private Security Agencies Regulation (PSAR) Act, 2005 under Ministry of Home Affairs.
