

Shri Rajnath Singh Hon'ble Minister of Defence Government of India

Born into a family of farmers, ShriRajnath Singh grew up to secure a master's degree in physics from Gorakhpur University. He started his political career as a student activist with Akhil Bharatiya Vidyarthi Parishad (ABVP) and went on to become the Bharatiya Janata Party (BJP) National President.

He was elected to Uttar Pradesh Legislative Council in 1988 and became Education Minister of Uttar Pradesh in 1991.

In November 1999 he became Union Minister of Surface Transport in Shri Atal Bihari Vajpayee government. In his role as Minister of Union Surface Transport, he initiated the NHDP (National Highway Development Programme), a dream project of Prime Minister Shri Atal Bihari Vajpayee.

In October 2000, he became Chief Minister of Uttar Pradesh& later in 2003, Shri Rajnath Singh became Minister of Agriculture in Shri Atal Bihari Vajpayee's cabinet at Centre.

In 2014 he became Union Minister of Home Affairs in Shri Narendra Modi government and in 2019 was made Raksha Mantri of the country.

His dream is to see India as a country that provides leadership to the world not only in the economic fields but all walks of life.

Shri Rajnath Singh's political life is clear emulation of the idea of "Antyodaya"— the rise of the last person" the political philosophy of Shri Deendayal Upadhyaya.





Shri Amit Shah Hon'ble Minister of Home Affairs and Cooperation, Government of India

Shri Amit Shah was born to Smt. Kusumben and Shri Anilchandra Shah, in an affluent Gujarati family on 22nd October 1964. Shri Amit Shah represents the emerging New India in every sense of the term. Leading the Party from the front for the last five years, he has been remarkably successful in expanding BJP's organisational footprint, securing one electoral victory after the other in State assembly elections. During his tenure, Party has become the world's largest political party with over 10 crore registered members.

Shri Amit Shah has risen to Head the ruling Party of India literally from the grass roots. Initially, he joined the Rashtriya Swayamsevak Sangh and later became an active member of the Akhil Bharatiya Vidyarthi Parishad (ABVP), to become its Ahmedabad city unit secretary. Later, he also shouldered the responsibilities of Secretary as well as Vice President of BJP, Gujarat State. In 1997, he became National Treasurer of the Bharatiya Janata Yuva Morcha (BJYM).His dedication, dexterity and above all result oriented performance made him In-Charge of several election campaigns of the National Leaders including that of L K Advani in 1991, Atal Bihari Vajpayee in 1996, both in Gandhi Nagar Parliamentary constituency. No wonder, when Shri Narendra Modi had decided to contest his first Assembly Election in 2001 from Rajkot-2 assembly constituency, Shri Amit Shah was again the Campaign Chief.

Beyond campaigns, Shri Amit Shah also became known for his adroit handling of organisational matters. In 2013, he was appointed as National General Secretary of the BJP and In-Charge of Uttar Pradesh. His painstakingly carried out efforts earned BJP a historic success in the Parliamentary elections of 2014. He took over as BJP National President in July 2014 and from there onwards there is literally no looking back. During the last five years, under the twin leadership of PM Narendra Modi and Party President Shri Amit Shah, BJP has successfully formed Govts in Haryana, Gujarat, Arunachal Pradesh, Uttar Pradesh, Uttarakhand, Tripura and Himachal Pradesh. Also, together with alliance partners, BJP has returned to power in States like Jharkhand, Maharashtra, Assam, Goa, and Manipur. Till recently in Jammu and Kashmir and currently in Bihar, Nagaland and Meghalaya, BJP is the junior partner of the ruling coalition

• A man of many parts, Shri Amit Shah is an avid Cricket lover, a sports person himself and a voracious reader whose major interests are history and literature. Being a religious person from the core of heart, Shri Amit Shah has a strong bond with Somnath Jyotirlinga On 22 Feb 2016, he became a trustee of the Somnath Trust, Gujarat.

- A five term MLA of Gujarat assembly (1997–2017), Shri Amit Shah was elected from Sarkhej Assembly Constituency for four consecutive elections and from Naranpura Assembly Constituency in 2012. In the assembly election of 2002, Shri Amit Shah was elected with the record margin of 1,58,036 vote, which created history in Gujarat assembly elections. Again in 2007, he defeated Congress party nominee by the highest margin of 2,32,823 votes for the fourth consecutive time.
- Shri Amit Shah was elected to Rajya Sabha, the Upper House of the Parliament on 19 August 2017 from Gujarat state.
- In the General election 2019, Shri Amit Shah has won with a whopping margin of 5,57,014 (70% vote share) from the 06-Gandhinagar Lok Sabha constituency of Gujarat state.

Shri Piyush Goyal

Minister of Commerce & Industry, Consumer Affairs & Food & Public Distribution and Textiles Government of India

Shri Piyush Goyal is the Minister of Commerce & Industry, Consumer Affairs & Food & Public Distribution and Textiles, Government of India. Leader of House in Rajya Sabha.

He is a Member of the Upper House (Rajya Sabha) of the Parliament of India and the Leader of House in Rajya Sabha. He was earlier the Minister of Railways and Coal (2017 - 19). He has also held additional charge of Minister of Finance and Corporate Affairs twice in 2018 and 2019. Earlier he was Minister of State (Independent Charge) for Power, Coal, New & Renewable Energy (2014 – 2017), and Mines (2016 – 17).

Shri Goyal's tenure has seen Indian Railways achieve its best ever safety record in 2018 - 20. This was achieved through holistic measures such as elimination of Unmanned Level Crossings (UMLCs) from the broad gauge network, production of safer coaches etc. Additionally, Mr. Goyal oversaw the launch of the first indigenous semi-high speed train Vande Bharat Express between Delhi and Varanasi.

The Power, Coal and New & Renewable Energy ministries led transformational changes in India's power sector including the fast tracking of electrification of the nearly 18,000 unelectrified villages in some of the remotest and inaccessible parts of the country, the rollout of the most comprehensive power sector reform ever (UDAY), the success of the world's largest LED bulb distribution programme (UJALA) for energy efficiency, and massive proliferation of renewable energy through the world's largest renewable energy expansion programme. Other achievements include the elimination of coal shortages to improve the energy security of India and successful conduct of transparent e-auctions of coal blocks. He also received the 4th Annual Carnot Prize in 2018 recognising the pathbreaking transformations in India's energy sector.

During his 35 year long political career, Mr Goyal has held several important positions at different levels in the world's largest political party, the Bharatiya Janata Party (BJP) and is in its National Executive. He has been the National Treasurer of the Party. In the 2019 General

Elections, he was a member of the Manifesto and Publicity Committees. He also headed the BJP's Information Communication Campaign Committee for the Indian General Elections 2014.

Shri Goyal has had a brilliant academic record – all-India second rank holder Chartered Accountant and second rank holder in Law in Mumbai University. He was a well-known investment banker and has advised top corporates on management strategy and growth. He also served on the Board of India's largest commercial bank, the State Bank of India and Bank of Baroda. He was also nominated by the Government of India to the Task Force for Interlinking of Rivers in 2002

His father, Late Vedprakash Goyal was Union Minister of Shipping, and the National Treasurer of the BJP for over two decades. His mother Chandrakanta Goyal was elected thrice to the Maharashtra Legislative Assembly from Mumbai. He is married to Seema, an active social worker, and has two children – Dhruv and Radhika, who have both graduated from Harvard University, USA.





Dr Subrahmanyam Jaishankar Hon'ble Minister for External Affairs Government of India

Dr. S. Jaishankar is India's External Affairs Minister since May 30th, 2019. He is a Member of the Upper House (Rajya Sabha) of India's Parliament from the state of Gujarat.

He was Foreign Secretary from 2015-18, Ambassador to United States (2013-15), China (2009-2013) and Czech Republic (2001-2004). He was High Commissioner to Singapore (2007-2009).

He has also served in other diplomatic assignments in Embassies in Moscow, Colombo, Budapest and Tokyo, as well in the Ministry of External Affairs and the President's Secretariat. He was also President – Global Corporate Affairs at Tata Sons Private Limited from May 2018.

Dr S. Jaishankar is a graduate of St. Stephen's College at the University of Delhi. He has a Masters in Political Science and an M. Phil and Ph.D in International Relations from Jawaharlal Nehru University, Delhi.

He is a recipient of the Padma Shri award in 2019 and has written a widely acclaimed bestselling book: The India Way: Strategies for an Uncertain World, which was published in 2020.





Dr Mansukh Mandaviya Hon'ble Union Minister of Health & Family Welfare, Chemicals & Fertilizers Government of India

Dr. Mansukh Mandaviya is the hon'ble Union minister for Health and Family Welfare and Minister for Chemicals & Fertilizers, Government of India. He is conferred a PhD degree from the Gujarat Institute of Development, and Research and holds a Post Graduate Degree in Political Science from Bhavnagar University.

Starting his political career in the mid-nineties, in a short span, he has become a respected political leader of the masses. He was very active in politics and serving people since his youth. With his hard work and intelligence, he was appointed as Secretary for state unit BJP in 2013 and General Secretary in 2014. Later in 2014, he was appointed as Gujarat State In charge of BJP's High-tech & Mega Membership Drive Campaign which led to 1 crore people joining BJP in Gujarat.

Mandaviya Ji is well known for his intellectual analysis and thought leadership, which he also exhibited in his speech on "2030 Agenda for Sustainable Development" at the United Nations. He has travelled to lot many countries to explore their policies & Management to help India grow at the fastest pace.

He has been a part of various important delegations. He has also played a vital role in the growth and development of New India with his hard work, organizational skills, and intellect. Touted as a 'Green Minister', Dr. Mandaviya has been at the forefront of several environmental issues and worked towards a clean and green nation.



H.E. Mr Shinzo Abe Former Prime Minister of Japan

H.E. Shinzo Abe was in office as Japan's Prime Minister first from September 2006 for one year and second between December 2012 and September 2020. His time in office is the longest in the country's modern history that dates to the 19th century.

Born in September 1954, he spent his childhood hearing his grandfather telling him of what he saw in Delhi 1957. Jawaharlal Nehru introduced Abe's grandfather, NobusukeKishi to the 100,000 large audience saying, "Standing next to me is the Prime Minister of the country I have never lost respect to."

With that being his cherished memory, while in office, Shinzo Abe strengthened bilateral ties between India and Japan to the height never scaled before. The address he gave at Central Hall, Indian Parliament, summer 2007, entitled "Confluence of the Two Seas," is still being cited in Delhi, Canberra, and in Washington, D.C., as the foundational conceptualization for the free and open Indo Pacific (FOIP) strategy and the quadrennial security cooperation known as QUAD. Japan during his time in office forged with India the most advanced trade and investment pact, laying the ground for Delhi Mumbai Industrial Corridor and other infrastructure development programmes.

He facilitated the country's economic rejuvenation policies, known collectively as Abenomics. Also, on his watch, it has been made possible for the country's armed forces to work as a collective unit, when need be, with the U.S. military. The country is equipping itself with 147 F-35 Aircraft and recalibrating some of its 20,000t helicopter carriers to accommodate the fifth-generation fighter aircraft.

Shinzo Abe also brought both TPP (Transpacific Partnership) and EU-Japan Economic Partnership Agreement into fruition.

He received Priyadarshni Academy Global Award in 2014. Later in 2020 he was awarded by the Indian government Padma Vibhushan.



Ms Sushmita Dev Member of Parliament, Rajya Sabha All India Trinamool Congress

Ms. Sushmita Devisa Rajya Sabha MP representing All India Trinamool Congress, West Bengal.She is a second term Member of Parliament.

She is a Member of Parliamentary Standing Committee on Empowerment of Women and Parliamentary Standing Committee on Science and Technology, Environment and Forests.

She has previously served as President, All India Mahila Congress from 2017-2021, National Spokesperson of A.I.C.C. and Chairperson, Silchar Municipal Board. During her first term in Parliament (2014-19), she was Member of the Lok Sabha from Silchar constituency representing the Indian National Congress. Prior to this, she was Member of Assam Legislative Assembly from 2011–2014.

She has been awarded Best Saansad Award by FAME INDIA, Best Women Parliamentarian for the Year-2016. She has been involved in social work and also serves as the President of AASHIYAN, an NGO. She is a lawyer by profession.

Ms. Chaturvedi began her political journey as an Assembly Delegate of the Indian Youth Congress in 2009. Ms Jothimani S Member of Parliament, Lok Sabha Indian National Congress

Ms. Jothimani S is a Lok Sabha MP from Indian National Congress, representing Karur Constituency of Tamil Nadu. She is a first term Member of Parliament. She is also the Member of Parliamentary Standing Committee on Industry.

She defeated a long-term Member of Parliament and Deputy Speaker of Lok Sabha by over 4.2 lakh votes in 2019 General Elections. She visited and met with constituents in person in over 6000 Villages in the constituency under the banner 'Connecting Karur'. She is working on several Constituency Development programs with focus on Education, Health, Skill Development and Employment, Water conservation, Agriculture, Women empowerment, Welfare of Transgender and Differently abled Persons.

She is very vocal and emphatic voice in Lok Sabha for issues relating to Tamil Nadu and especially those concerning the oppressed and marginalized. She led a People's movement and succeeded in stopping destruction of a forest areas in Vallimalai and R.Kombai in Vedasanthur Constituency.

She obtained permanent stay from high court for sand mining in River Amaravathi after three years sustained struggle and saved the formers and agricultural labourers livelihood, brought drinking water to Dalit people, and successfully ended decades-old discrimination.

She interacted with Kerala and Karnataka Chief Ministers to find a solution to thousands of Tamils doing business there and helped them to continue their business. When the Egg producers of Tamil Nadu were unable to transport their produce across, she spoke to the Kerala chief minister and immediately eased the bottleneck.

She was an active worker in Indian Youth Congress and served as the General Secretary. She ran a program 'KarkaKasadara' (Learn Flawlessly) for students.



Mr B.V.R. Subrahmanyam Secretary, Department of Commerce Ministry of Commerce & Industry Government of India

Mr. B.V.R. Subrahmanyam is a Member of the Indian Administrative Service (1987 batch - Chhattisgarh cadre). He has done BE (Mechanical) from Delhi University with distinction and MBA with distinction from London Business School, University of London and Master's in International Law and Economics from World Trade Institute, University of Bern, Switzerland with distinction.

He has served in different capacities at various levels in the Central and State Governments. He has worked as Director in the Department of Commerce, as Private Secretary to the former Prime Minister of India and also served as Joint Secretary in Prime Minister's Office. He also worked as Sr. Adviser to Executive Director in World Bank, Washington D.C. Also remained as Additional Chief Secretary in the Government of Chhattisgarh. In recent years he has served as Chief Secretary in Jammu & Kashmir.

At present, he is serving as Commerce Secretary in the Department of Commerce, Ministry of Commerce & Industry, Government of India w.e.f. 1st July 2021.





Mr Rameshwar P. Gupta Secretary, Ministry of Environment Forest & Climate Change Government of India

Mr R. P. Gupta is presently working as Secretary, MoEFCC, Gol. Shri Gupta is an IAS Officer of 1987 Batch of Gujarat cadre. He did B. Tech. from IIT, Kanpur in Aerospace Engineering. Apart from working in the field assignments in earlier part of his career as District Development Officer, Municipal Commissioner, District Collector etc., he mainly worked in the field of education, land record and energy at the policy making levels. In every field, the focus was on streamlining the system and introduction of modern technology to make the system more people friendly and responsive to their needs.

In the area of land records, digitization of village maps and land parcels and synchronizing them with satellite imagery along with geo-stationery tagging was done. Resurvey of state of Gujarat using modern technology was also started this time.

In the field of education, he introduced completely transparent computerized system of teachers' recruitment enabling the State to recruit tens of thousands of teachers purely on merit in a short period of one month. His other contribution was in conceptualizing and implementing an annual assessment of quality of education in about 35000 Government schools in the state of Gujarat in digitized format to compare schools, tehsils and districts across the State but also enabling improvement or deterioration over time and assessing teachers' performance.

He also worked as Secretary, Department of Food and Civil Supplies dealing with the Public Distribution System (PDS). In this capacity, apart from fully computerizing the PDS right from Fair Price Shop to State Government level, system of biometric authentication was implemented to eliminate the leakages. In this capacity he also dealt with LPG and Kerosene distribution through PDS as cooking and lighting fuel. In the area of energy, he has worked in Ministry of Coal as Joint Secretary for two and half years and in Energy Department of Government of Gujarat. In his last assignment he was working as Special Secretary in NITI Aayog dealing with the subject of Energy.



Mr B.B. Swain Secretary, Ministry of Micro Small & Medium Enterprises, Government of India

Mr B.B. Swain joined the Indian Administrative Service (IAS) in 1988 in Gujarat cadre. Presently, he is holding the charge of Secretary in the Ministry of Micro, Small and Medium Enterprises.

Mr. Arvind Singh joined the Indian Administrative Service in 1988 after acquiring Bachelor's and Master's degrees in economics from St. Stephen's College, Delhi and the Delhi School of Economics. His initial assignments were as Assistant Collector at Aurangabad and as Chief Executive Officer of Aurangabad and Nagpur Zilla Parishads. After a stint in the Chief Secretary's office at Mumbai, he moved to Kolhapur as District Collector. Movingto the Centre in 2001, he worked in various ministries including Commerce and Shipping and as Private Secretary to the Minister of Agriculture.

Mr. Arvind Singh (IAS; MH:88) has been appointed as Secretary, Ministry of Tourism and has taken over the charge on 27th January, 2021. His previous assignment was as Chairman, Airport Authority of India, M/o Civil Aviation. He has also served as Additional Chief Secretary (Energy) in Government of Maharashtra, prior to that he was Chairman and Managing Director of Maharashtra State Power Generation Company Ltd. Chris Anderson is the curator of TED, a nonprofit media organization that leverages the power of ideas to make a better future. Chris was born in a remote village in Pakistan in 1957. He spent his early years in India, Pakistan and Afghanistan, where his parents worked as medical missionaries, and he attended an American school in the Himalayas for his early education. After boarding school in Bath, England, he went on to Oxford University, graduating in 1978 with a degree in philosophy, politics and economics. Chris then trained as a journalist, working in newspapers and radio, including two years producing a world news service in the Seychelles Islands. Back in the UK in 1984, Chris was captivated by the personal computer revolution and became an editor at one of the UK's early computer magazines. A year later he founded Future Publishing with a \$25,000 bank loan. The new company initially focused on specialist computer publications but eventually expanded into other areas such as cycling, music, video games, technology and design, doubling in size every year for seven years. In 1994, Chris moved to the United States where he built Imagine Media, publisher of Business 2.0 magazine and creator of the popular video game users website IGN. Chris eventually merged Imagine and Future, taking the combined entity public in London in 1999, under the Future name. At its peak, it published 150 magazines and websites and employed 2,000 people. This success allowed Chris to create a private nonprofit organization, the Sapling Foundation, with the hope of finding new ways to tackle tough global issues through media, technology, entrepreneurship and, most of all, ideas. In 2001, Sapling acquired the TED Conference, then an annual meeting of luminaries in the fields of Technology, Entertainment and Design held in Monterey, California. Chris left Future to work full-time at TED, and under his continued stewardship over 3,600 talks and animated lessons have been released free on the TED website, with 100,000 more on YouTube. He is the author of the New York Times bestseller TED Talks and has overseen the introduction of TEDx, TED-Ed, TED Fellows and the Audacious Project, a new form of collaborative philanthropy. He is a founding partner of Countdown, a global initiative to champion and accelerate solutions to the climate crisis, turning ideas into action.
