ederation of Indian Chambers of Commerce and Industry (FICCI), with the support of the Ministry of Commerce & Industry, Government of India is organizing 1st INDIA AUSTRALIA ECTA TRADE EXPO in Sydney, Australia in March 2023.

The sole objective of the Expo is to bring Indian and Australian industry together to work jointly for extensive market access and to increase trade under the Economic Cooperation and Trade Agreement (ECTA). The India-Australia FTA is an ambitious pact with significant commitments to tariff cuts. Australia will provide zero-duty market access for 96.4 percent value of Indian exports (98 per cent of tariff lines).

India and Australia on April 2nd 2022, signed an Economic Cooperation and Trade Agreement (ECTA) that seeks to almost double bilateral trade in the next five years to \$45-50 billion from \$ 27billion now. Hon'ble Minister of Commerce Shri Piyush Goyal and Australian minister for trade, tourism, and investment Dan Tehan signed the India-Australia ECTA in a virtual ceremony in the presence of Hon'ble Prime Minister of India Shri Narendra Modi and his Australian counterpart Scott Morrison. It has come into effect from December 29, 2022. The deal provides duty-free market access to over 6,000 broad sectors of India, including Textiles (Yarns, Fabric, Apparels, Knits), leather, furniture, jewelry, Footwear, Handlooms, Gems & Jewelry, Home furnishing, Technical Textiles, Pharmaceuticals and Medical devices, IT & Services, Food & Agriculture, Construction, Building materials, Mining & Minerals and Sports Goods.











WHY AUSTRALIA

- Australia is one of the important trading partners of India. There is an immense potential to increase India's exports to this region.
- India's exports to Australia include textiles, precious and semi-precious stones, made-ups, floor covering, jewelry, footwear, travel goods, handbags, Leather goods and Agro products etc.
- In addition, the recent signing of India Australia ECTA, has given the trade a much-needed spark to enhance and scale new heights of bilateral trade engagements between the two economies. The agreement shall open doors to opportunities across diverse areas like Mining and Minerals, Healthcare and Pharmaceuticals, Information technology, Gems and jewellery and Textiles, generating about a million jobs in India.
- Under this agreement, tariffs will be eliminated on more than 85 per cent of Australian goods exports to India (valued at more than \$12.6 billion a year). India is expected to get zero-duty access to Australia for its goods such as wines, almonds, lentils and certain fruits over five years.
