Almost 95% of the cold storages in the state are for the storage of marine products and for the captive use of exporters. Among the strategies of India Cooling Action Plan of Government of India, development of energy efficient and renewable energy based Cold Chain has been identified. In order to maintain sustainability in agriculture sector, it is important to have deliberations among the stakeholders to implement the Energy efficient Cold Chain Infrastructure.
