## Covid active caseload decreases to 3.6 mn; positivity rate at 16.98%: Govt

India's COVID-19 active cases count has decreased to 36,18,458 with a net decline of 55,344 cases being recorded in the active caseload in a span of 24 hours, while the daily positivity rate dropped to 16.98 per cent, the Union health ministry said on Sunday. The total active caseload now comprises 14.66 per cent of the country's total infections, it said. Ten states--Karnataka, Maharashtra, Kerala, Rajasthan, Tamil Nadu, Andhra Pradesh, Uttar Pradesh, West Bengal, Gujarat and Chhattisgarh--cumulatively account for 74.69 per cent of the country's total active cases, the ministry said. A declining trend in the positivity rate is also observed which has dropped to 16.98 per cent (May 16) from 24.47 per cent recorded on May 3, it said. India's cumulative recoveries have reached 2,07,95,335 with 3,62,437 patients recuperating in a span of 24 hours. It outnumbers the country's daily COVID-19 cases for the fifth time in the last six days, the ministry said.

### CBIC starts special drive to clear pending GST refund claims by month-end

The Central Board of Indirect Taxes and Customs (CBIC) has launched a special drive to clear all pending GST refunds by month-end. The 15-day Goods and Services Tax (GST) refund drive is on the lines of an ongoing similar drive organised by the CBIC for refund of customs and duty drawback claims. In an instruction to all Principal Commissioners of Central Tax formations, the CBIC said there is a need to focus on timely disposal of all pending GST refund claims in order to provide immediate relief to business entities, especially MSMEs, in the difficult times of second wave of the COVID-19 pandemic. "It is hereby instructed that a 'Special GST Refund Disposal Drive' will be launched by all Central Tax formations during the period from 15th May 2021 to 31st May 2021 for processing and disposal of all pending GST refund claims on priority," it said.

## Govt issues guidelines on Covid management in rural, peri-urban areas

As rural areas see a rise in Covid-19 cases, the Centre on Sunday issued new guidelines for containment of the virus advising that peri-urban and rural areas plan a minimum 30-bedded Covid Care Centre for asymptomatic cases with comorbidities or mild cases where home isolation is not feasible. Provision of Rapid Antigen Test (RAT) kits should be made at all public health facilities including Sub-centres or Health and Wellness Centres and Primary Health Centres, the Union Health Ministry said. Noting that besides urban areas reporting a large number of cases, a gradual ingress is now being seen in peri-urban, rural and tribal areas as well, the ministry released the 'SOP on Covid-19 Containment and Management in Peri-urban, Rural & Tribal areas' to enable communities strengthen primary level healthcare infrastructure at all levels to intensify Covid-19 response.

### India's once-in-a-century budget runs into trouble as virus strikes back

India's annual budget in February was lauded by many and raised hopes it would drive a sharp economic revival, but there are now fears that its promise may fall flat as it did not account for a crippling second wave of Covid-19 infections. The budget aimed to revive Asia's third-largest economy via investing in infrastructure and health care, while relying on an aggressive privatisation strategy and robust tax collections - on the back of projected growth of 10.5 per cent - to fund its spending in the fiscal year. Finance Minister Nirmala Sitharaman said India would not see such a budget in "100 years". At the time, a massive Covid-19 vaccination drive and a rebound in consumer demand and investments had put the economy on track to recover from its deepest recorded slump. The South Asian country is battling the world's second highest coronavirus caseload after the United States, recording some 300,000 cases and about 4,000 deaths a day. With many parts of the country under varying degrees of lockdown, most of the growth projections that the budget was built around are now mired in uncertainty.

## Covid-19: Centre asks states to keep ration shops open on all days

The Centre on Sunday asked the state governments to keep ration shops, also called fair price shops, open for a longer duration and on all days to ensure timely and safe distribution of both subsidised and free foodgrains to the poor. An advisory in this regard has been issued by the Union Food Ministry following representations that during the current lockdown in some states/UTs, ration shops' timings have been curtailed due to which the intended beneficiaries might not be getting adequate time to lift their entitled foodgrains. "In view of ongoing lockdown in some States/UTs, that may curtail the functioning hours of Fair Price Shop (FPS), an advisory has been issued on 15th May, 2021...to keep the FPSs open, preferably on all days of the month," the ministry said in a statement. The Centre is distributing highly monthly subsidised foodgrains of 5 kg per person at Rs 1-3 per kg via ration shops to over 80 crore poor under the National Food Security Act (NFSA).

### SBI to sell three NPA accounts next month for recovery of over Rs 235 cr

The State Bank of India (SBI) will sell three bad accounts to asset reconstruction companies or other financial institutions next month to recover dues of over Rs 235 crore, according to a sales notice. In terms of the bank's policy on sale of financial assets, in line with regulatory guidelines, SBI said it has placed Heavy Metal and Tubes Ltd, Khare and Tarkunde Infrastructure Pvt Ltd and Elize International Ltd for sale to recover a total of Rs 235.32 crore. Heavy

Metal has outstanding dues of Rs 116.91 crore to the bank, Khare and Tarkunde owes Rs 99.84 crore and Elize International Rs 18.57 crore. The bank has set the reserve prices for these NPA accounts for sale at Rs 27.50 crore, Rs 15 crore and Rs 8 crore, respectively. The e-auction of Heavy Metal and Tubes; and Khare and Tarkunde will take place on June 7, while that of Elize will be on June 8.SBI said the interested ARCs/banks/NBFCs/FIs can conduct due diligence of these assets with immediate effect, after submitting expressions of interest and executing a non-disclosure agreement with the bank.

### Govt may amend DICGC Act in monsoon session to provide timely service to ailing bank depositors

In a bid to ensure timely support to depositors of stressed banks, the government may bring amendment to DICGC Act in the monsoon session with the objective to provide account holders easy and time-bound access to funds to the extent of the deposit insurance cover. Last year, the government raised insurance cover on deposit five-folds to Rs 5 lakh with a view to provide support to depositors of ailing lenders like Punjab and Maharashtra Co-operative (PMC) Bank. Following the collapse of PMC Bank, Yes Bank and Lakshmi Vilas Bank too came under stress leading to restructuring by the regulator and the government. The amendment to the Deposit Insurance and Credit Guarantee Corporation (DICGC) Act, 1961 is the budget announcement made by the Finance Minister and the Bill is almost ready, sources said.

## COVID-19 brings about behavioural change in cash usage, say experts

The COVID-19 pandemic has brought about a behavioural change in usage of cash with people withdrawing larger amounts from ATMs but preferring to make digital modes to make payments, said, experts. The ferocity of the second wave of the coronavirus pandemic has scared people, forcing them to withdraw larger amounts from the ATMs with a view to avoid frequent visits. The money thus withdrawn is mostly held for emergency use and often payments are being made through UPI and other digital modes.

Talking about the behavioural change in currency usage, Sarvatra Technologies founder and MD Mandar Agashe said that in view of the lockdown and social distancing norms, people are not venturing out to banks and ATMs as frequently.

### Covid resurgence to cause short-term disruption in credit offtake: HDFC Securities

The second wave of pandemic is expected to cause short-term disruption in credit offtake, said HDFC Securities in a report. "We expect recovery in credit growth over the medium term for our coverage universe, " the report said. However, it pointed out that industrial credit growth remained muted although registering positive YoY growth for the first time since September. "The large industrial credit, which constitutes 82 per cent of industrial credit, continued to de-grow at (-) 0.8 per cent YoY as the Capex cycle still remains elusive."

### Hotel industry says it lost Rs 1.3 trillion revenue in FY21, seeks help

The Indian hotel industry has taken a hit of over Rs 1.30 lakh crore in revenue for the fiscal year 2020-21 due to the impact of the COVID-19 pandemic, the Federation of Hotel & Restaurant Associations of India (FHRAI) said on Sunday. The apex industry body said it has submitted representation to the Prime Minister and a few other union ministers urging immediate support from the government to save the hospitality sector from imminent collapse and has requested for several fiscal measures for this.

"The Indian hotel industry's total revenue in FY2019-20 stood at Rs 1.82 lakh crore. As per our estimates, in FY2020-21, approximately 75 per cent of the industry's revenues got wiped off. That is more than Rs 1.30 lakh crore revenue hit," the FHRAI said in a statement.

## Covid 2.0 crisis: Majority MSMEs don't expect improvement in business activities in 6 months: Survey

Amid business uncertainty due to the second wave of the pandemic, the majority of Covid-hit MSMEs don't expect any improvement in their business activities over the next six months. According to a survey by credit rating agency Care Ratings, involving 305 respondents including small and medium enterprises between April 27 and May 11 to gauge the impact of ongoing lockdowns on economic prospects, 54 per cent expected the business conditions to worsen over the next six months. 34 per cent respondents expected no change in the business conditions while only 12 per cent anticipated an improvement in business activities.

Recovery of MSMEs in multiple sectors including retail, aviation, hospitality, and others, which were among the worst hit due to Covid last year, was nearing the pre-pandemic levels before the second wave struck around post-February, and cases swiftly started to climb up.

### Sales of AC, other cooling products again hit by pandemic in peak season; cos now pin hopes on extended summer

For the second consecutive year, sales of air conditioners (ACs) and refrigerators have been hit during the peak season of April and May due to the localised lockdowns and restrictions on account of surging Covid cases in the country. The pandemic situation has forced companies to recalibrate their target and go for pre-Covid (2019) sales number without being too aspirational. Leading players in the segment including Voltas, Daikin, Blue Star, Panasonic and Haier reported almost 75 per cent dip in April sales this year when compared with the same month of 2019 performance. Moreover, May 2021 has been a complete washout so far for them.

## Truck rentals on key trunk routes down by further 5-7% in past fortnight

## Truckers demand relief measures as losses mount to Rs 42,000 cr due to lockdowns

#### India's Oil demand shrinks further as coronavirus crisis persists

India's oil demand worsened in the first half of May as large parts of the nation remained under local lockdowns to battle the world's worst outbreak of Covid-19.Sales of road transport fuels during May 1-15 dropped by a fifth from the previous month and about 28 per cent from the same period in 2019, according to people familiar with preliminary data from the country's three biggest retailers. Average daily sales of gasoline -- used in cars and motorcycles -- fell to about 53,300 tons, the lowest in a year. Sale of diesel -- the country's most-used fuel and a proxy for economic health -- dropped to a seven-month low of 147,300 tons a day during May 1-15. The plunge in consumption at the world's third-biggest crude consumer will weigh on sentiment on oil prices and damp expectations for a strong global demand rebound in the summer. The International Energy Agency has lowered its 2021 global oil demand forecast from the impact of the raging virus outbreak in India, while OPEC and its allies are already taking a cautious view.

### Haryana extends lockdown till May 24 to curb the spread of Covid-19

In order to contain the COVID cases upsurge, the Haryana Government on Sunday announced extension of the COVID-induced lockdown for another week. The lockdown will be in effect till May 24 with strict measures, informed the state home minister on Sunday." Mahamari Alert/Surkshit Haryana extended from May 17 to May 24. Stringent measures will be taken to implement the alert," tweeted Haryana Home MInister Anil Vij.A week-long complete lockdown was already imposed in Haryana till May 17 with effect from May 10. This had been in continuation of the first lockdown imposed on May 3 for a week. Haryana reported 9,676 fresh COVID cases and 144 deaths on Saturday, according to the state health department. The new cases pushed the infection count to 6,85,312. The active number of COVID cases in the state stands at 95,946. With the new fatalities, the COVID death toll in the state has mounted to 6,546.

#### 'Alarming': Centre directs states to prevent dumping of corpses in Ganga

The union government directed states to prevent dumping of dead bodies in Ganga and focus on their safe disposal and providing support for ensuring dignified cremation. It said dumping of dead bodies or partially burnt corpses in the river Ganga and its tributaries is most undesirable and alarming. The Centre's order comes amid reports of hundreds of suspected coronavirus-linked dead bodies found floating in river Ganga in Uttar Pradesh and Bihar. "Stopping of dumping of dead bodies as well as their safe disposal and protection of water quality has to be attended to on war footing," Ministry of Jal Shakti said in an official statement. The government said along with action to stop dumping of dead bodies in river, states were also directed that burying of dead bodies in sand must also be prevented.

### States to receive nearly 51 lakh COVID-19 vaccine doses in next three days: Centre

More than 1.84 crore COVID-19 vaccine doses are still available with states and UTs, while nearly 51 lakh doses are in the pipeline and will be received by them within the next three days, the Union Health Ministry said on Sunday. The Centre has so far provided more than 20 crore vaccine doses (20,28,09,250) to states and UTs free of cost, it said. Of this, the total consumption, calculated based on average up to May 14, including wastages, is 18,43,67,772 doses, according to data available at 7 pm on Saturday.

## Covaxin effective against India, UK coronavirus strains: Bharat Biotech

Bharat Biotech on Sunday said its COVID-19 vaccine 'Covaxin' has been found to be effective against coronavirus strains found in India and the UK.Citing a study published in peer-reviewed medical journal Clinical Infectious Diseases, the Hyderabad-based vaccine major noted that vaccination with Covaxin produced neutralising titres against all key emerging variants tested, including B.1.617 and B.1.1.7, first identified in India and the UK, respectively.The study was conducted in collaboration with the National Institute of Virology and Indian Council of Medical Research, it added.

"Covaxin gets international recognition yet again, by scientific research data published demonstrating protection against the new variants. Yet another feather in its cap," Bharat Biotech co-founder and Joint Managing Director Suchitra Ella said in a tweet. She also tagged PMO India, Finance Minister Nirmala Sitharaman and Health Minister Harsh Vardhan, among others, in the tweet.

### Tamil Nadu allows Chinese Covid vaccine makers to bid unlike Mumbai

Tamil Nadu government's global tender for 3.5 crore doses of Covid-19 vaccine does not restrict Chinese vaccine makers from bidding, said an official."We are allowing every product (vaccine) as long as it is approved by the World Health Organisation (WHO) and licensed by the Drugs Controller General of India (DGCI)," a senior official told IANS.According to the official, about six vaccines have been approved by WHO and three by DCGI.

On the other hand, the Brihanmumbai Municipal Corporation in its one crore vaccine dose tender has disqualified companies located in countries sharing borders with India from participating in the bid, thus disqualifying Chinese vaccine manufacturers.
