## India becomes second country to reach 20 crore vaccination coverage after US

India has become the second country after the US to have crossed 20 crore cumulative COVID-19 vaccination coverage, the Union health ministry said on Wednesday. India achieved this coverage in 130 days as against the USA's feat in 124 days, the ministry said. #### UK launches consultation round in run-up to FTA talks

The UK has launched formal preparations for a free-trade agreement with India which will open new opportunities for various industries and boost bilateral trade in science and services and thereby job creation. The consultation follows the Enhanced Trade Partnership agreed at the virtual meeting between the Prime Minister Narendra Modi and his British counterpart Bris Johnson on 4 May, where they launched a '2030 Roadmap' which will provide a framework for UK-India relations. Trade Secretary Liz Truss started preparations on Tuesday for a trade deal with India with the launch of a 14-week consultation to seek the views of the public and businesses, in a run-up to the formal negotiations for a UK-India FTA aiming to start in autumn. "The UK wants a deal that slashes barriers to doing business and trading with India's £2 trillion economy and market of 1.4 billion consumers. ## Panel to examine valuation of services by casinos, online gaming for GST

The government has set up a panel of state ministers for better valuation of services of casinos, online gaming portal and race courses for levying goods and services tax (GST). The seven-member panel, convened by Gujarat Deputy Chief Minister Nitin Patel, will also examine whether any change is required in the legal provision for better means of valuation of these services. The group of ministers (GoM) will "examine the issue of valuation of services provided by casinos, race courses, and online gaming portals and taxability of certain transactions in a casino, with reference to the current legal provisions and orders of courts," said its terms of reference (ToR). It will also examine the administration of such valuation provisions and if an alternative means of valuation is recommended.

## Report status on IT rules 'preferably today': Govt tells social media firms

The Indian government is in no mood to give more time to social media firms to comply with new social media rules. The Ministry of Electronics and Information Technology (MeitY), in a notification, has asked all social media intermediaries to give details of the complaint redressal mechanism with an officer being based in the country, as soon as possible. This will include a chief compliance officer, a nodal contact person for 24x7 coordination with law enforcement agencies, and a resident grievance officer, and the physical contact address in India, preferably by

today itself, said the notification. #### Centre responds to WhatsApp's lawsuit, says committed to upholding privacy

The government, in response to WhatsApp filing a case in the Delhi High Court against new rules that would require it to break end-to-end encryption, said the requirement was necessary for public interest and identifying the first originator of messages leading to crimes.

"It is very important to note that such an order, to trace first originator, under Rule 4(2) of the said guidelines shall be passed only for the purposes of prevention, investigation, punishment etc. of inter alia an offence relating to sovereignty, integrity and security of India, public order incitement to an offence relating to rape, sexually explicit material or child sexual abuse material punishable with imprisonment for not less than five years," the Ministry of Electronics and Information Technology said in a statement on Wednesday.

# **GST Council panel not for exempting Covid vaccines**

#### DGFT services on trader code, Aadhaar link to remain suspended from June 1-6

The government on Wednesday said that services of the Directorate General of Foreign Trade such as application for a new importer-exporter code (IEC), modification applications and one-time linking of Aadhaar for e-sign purposes will not be available from June 1-6 due to non-availability of PAN Validation Services. "In reference to the Press release by Central Board of Direct Taxes on "Launch of new e-filing Portal of the Income Tax Department - Non-availability of e-filing services from June 1-6, 2021", it is informed that some DGFT services wherein CBDT PAN validation services are being consumed in the DGFT IT systems will get impacted during this period," DGFT said in a statement.

#### Economic impact of Covid-19 is huge, world won't be the same: PM Modi

The economic impact of the Covid-19 pandemic is "huge", and the world will not be the same after the virus recedes, Prime Minister Narendra Modi said Wednesday. The once-in-a-lifetime pandemic has brought tragedy and suffering at the door-step of many, Modi said. "The pandemic has impacted every nation. The economic impact is huge as well," he said while delivering keynote address at the Vesak Global celebrations.

The prime minister's remarks come in the backdrop of rating agencies revising their growth forecasts as the second wave of the Covid-19 pandemic has impacted economic recovery and increases the risk of long-term scarring. Recently, the International Monetary Fund (IMF) has said it will revisit the growth forecast for India, and for the global economy in July. The economic fallout of the second wave of the pandemic is expected to be severe as suggested by high-frequency indicators such as mobility trends, auto sales, and rising unemployment rates, among others.

## Govt may announce stimulus when unlock phase commences

With the world's worst pandemic outbreak scarring nascent economic recovery, the government may at the beginning of the unlock phase announce another stimulus package for the most hit sectors such as small business and self-employed, Bernstein said. The brokerage in a note said its macro index suggests a deterioration in economic activity during April/May. "Energy consumption has moderated, with power down over 4 per cent and oil consumption down over 16 per cent in May so far (all 2-year CAGR). #### Pandemic Lows: Formalisation of jobs takes a big hit

If formalisation of employment – jobs with essential social security cover – gathered pace for a few years till 2020-21, the process has since taken a big hit due to the pandemic. New enrollment under the two prominent social security organisations – EPFO and ESIC – fell nearly a quarter on year in 2020-21, according to official data. Clearly, not just job creation, but even formalisation, which has been incentivised by the Narendra Modi government with a significant fiscal cost, has suffered as the pandemic ravaged the economy. Of course, a gradual saturation of the formalisation process due to the focused drive in recent years may be in part a reason for the fall in number of new subscribers, but the effect of the pandemic and the economic slowdown cannot be gainsaid.

#### Inflation back on higher input prices, rural economy disruptions: Crisil

Higher input prices and disruptions to the rural economy have resulted in price pressures and inflation is back to haunt us, a rating agency said in its research report on Wednesday. The report by Crisil said it sees upside risks to its 5 per cent estimate on consumer price inflation in FY21 because of this. It can be noted that the Reserve Bank is required to maintain the crucial number at 4 per cent in the medium term, with a 2 percentage point leeway on either side as part of its inflation target. A surge in inflation worries had led it to desist from introducing rate cuts during much of FY21, despite the over 7.6 per cent contraction in the economy.

## Centre may need to borrow Rs 1.6 trn more to pay states for revenue loss

India may need to borrow more for a second straight year to compensate its states for their revenue loss due to a shortfall in a nationwide consumption tax collection, according to people with knowledge of the matter. The additional borrowing requirement is estimated at 1.58 trillion rupees (\$21.7 billion) in the fiscal year started April 1, said the people, who asked not to be identified citing rules. A panel on goods and services tax will meet on Friday to discuss compensation to states, among other issues.

## Banks sanction over Rs 15 lakh crore under Mudra Yojana

The finance ministry on Wednesday said banks and financial institutions have sanctioned about Rs 15 lakh crore to over 28 crore beneficiaries under the Mudra scheme in the last six years. Pradhan Mantri MUDRA Yojana (PMMY) was launched by Prime Minister Narendra Modi on April 8, 2015, to promote entrepreneurship. As of March 26, 2021, loans sanctioned by member lending institutions amounting to Rs 15.10 lakh crore to 28.81 crore beneficiary, the Department of Financial Services under the Finance Ministry said in a tweet. Under the scheme, collateral-free loans up to Rs 10 lakh in three categories - namely Shishu, Kishore and Tarun for income-generating activities in manufacturing, trading and services sectors and activities allied to agriculture are provided, it said.

# NCUI voices concerns over RBI guidelines for merger of district central co-op banks with state co-op banks

The National Cooperative Union of India (NCUI) on Wednesday raised serious concerns over the Reserve Bank's guidelines for merging District Central Co-operative Banks (DCCBs) with State Cooperative Banks (StCBs), saying the move will "destroy" the rural cooperative credit institutions. On May 24, the Reserve Bank of India (RBI) issued the guidelines and said it will consider amalgamation of DCCBs with StCBs subject to various conditions, including that a proposal should be made by the state government concerned. "This is unjustified, and it will destroy the rural cooperative credit institutions in the country causing a lot of problems to the farmers," NCUI President Dileep Sanghani said in a statement.

#### 2-wheelers to account for 8-10% of sales by 2025; 30% by 3-wheelers: ICRA

The electric two and three-wheelers volume are expected to account for 8-10 per cent and 30 per cent of new vehicle sales in the country by 2025, respectively, owing to low operating cost and attractive subsidy support, among others, ratings agency ICRA said on Wednesday. The penetration levels in cars and trucks, however, are likely to remain low in the medium-term, it said. Globally, EVs now account for 4.4 per cent of new car sales during CY2020 and their share is likely to cross 5 per cent level this calendar year, as per ICRA.

Electric two-wheeler (2W) and three-wheeler (3W) segments have relatively lower dependency on commercial charging infrastructure, owing to limited span of commute and can also adopt battery swapping to allay charging related concern for commercial applications.

### Migrant workers return to Surat's diamond quarters

Sparkle is returning to the narrow alleys of Surat's diamond quarters. Production of cut and polished diamonds in the city has improved in the last fortnight with migrant workers beginning to return to their workplace as the pace of Covid-19 spread slows and vaccinations pick up. Diamond production, which had dwindled by 30% in the first half of May, has recovered and leading diamond exporters say that production is now down by only 10-15%. ## Hit hard by pandemic, retailers, traders seek waiver of property tax and license fee

#### NHAI issues guidelines for toll plazas to reduce waiting time

The NHAI on Wednesday said it has issued guidelines to ensure not more than 10 seconds service time per vehicle even during the peak hours at toll plazas to ensure minimal waiting time. The National Highways Authority of India (NHAI) in a statement said the new set of guidelines will also ensure seamless flow of traffic at the toll plazas by not allowing vehicles to queue up more than 100 metres. Noting that although at most of the toll plazas, there is no waiting time after the mandatory 100 per cent FASTag, the NHAI said, "even then if there is a queue of waiting vehicles of more than 100 metres due to some reason, the vehicles will be allowed to pass without paying toll till the queue comes within 100 meters from the toll booth".

## Rail freight up 10% in April 1-May 25 over 2019: Government

# No IUC drags telco ARPUs in FY4Q despite strong user adds: India Ratings

The withdrawal of interconnect usage charge (IUC) this year has dragged down average revenue per user (ARPU) of telecom companies, despite them reporting strong user addition in the January-March quarter, India Ratings and Research said. As per the Telecom Regulatory Authority of India data, India's wireless subscriber base grew by 8.3 million to total 1,168 million users in the month of February which is the highest addition in the last one and a half year, the ratings firm said in a note.

## Night curfew relaxed in 36 cities of Gujarat; day time curbs to continue

Considering a significant drop in the new coronavirus cases in Gujarat, the state government on Wednesday decided to relax the night curfew timings by an hour in 36 cities, while the day time restrictions will remain in place. Chief Minister Vijay Rupani made the announcement regarding the revised curfew timings after a cabinet meeting in Gandhinagar. From Friday, the night restrictions on people's movement will be effective from 9 pm to 6 am in 36 cities, the chief minister said. Currently, the night curfew is being enforced from 8 pm to 6 am.

"Coronavirus cases are decreasing in Gujarat. From nearly 14,600 new cases, the highest daily peak registered on April 30, about 3,200 cases are currently emerging every day. Hence, we have decided to relax the night curfew. The curfew will now be from 9 pm to 6 am," Rupani said.

#### Covid positivity rate falls to 9.42%, recoveries continue to outnumber new cases

India's daily COVID-19 positivity rate has reduced and now stands at 9.42 per cent, while the count of single-day recoveries outnumbered that of new cases for the 13th consecutive day, the Union Health Ministry said on

Wednesday.A total of 22,17,320 tests, the highest in a day, were conducted on Tuesday taking the cumulative number so far in the country to 33,48,11,496, while the daily positivity declined to 9.42 per cent, it said. This is the second day in a row that the case positivity rate has remained below 10 per cent, the ministry said. The weekly positivity rate has also declined to 11.45 per cent. India registered 2,95,955 recoveries in a single day as against 2,08,921 new cases. The number of cumulative recoveries has reached 2,43,50,816. The count of daily new cases has remained below three lakh for 10 consecutive days now.
