# Govt identifies items for customs exemptions review, seeks industry views

The government has identified a host of customs exemptions for review and has invited suggestions from trade and industry bodies on the same. Importers, exporters, domestic industry and trade associations are invited to give views on the subject for consideration by the government by August 10 on the 'MyGov.in' portal. Some key products covered under the list include fabrics, games/sports requisites, magnetron for microwave manufacturing, specified parts for PCB, set-up box, routers, broadband modem, contraceptives and artificial kidney.

The list also includes magnetic tapes, photographic, filming, sound recording/ radio equipment, parts/ raw material for manufacture of goods supplied for off-shore oil exploration, specified machinery/ parts covered in textile industry.

# Revised wage rate index likely next month; base year to be 2019

The government will soon revive the wage rate index and change its base year to 2019 from 1965. The revised index will capture the impact of inflation on wages and form the basis for determining the statutory national floor level minimum wage, said officials. "Work is in the final stages. The index with revised base year could be launched next month," said a senior labour ministry official, who did not wish to be identified. "The appreciation in the index till 2019 will be used to determine the minimum wages in the country."

# India poised for double-digit growth this fiscal, says Niti Aayog VC

With India's story remaining "very strong", the economy will register a double-digit growth in the current fiscal and the disinvestment climate also looks better, said Niti Aayog Vice Chairman Rajiv Kumar. He also asserted that the country is prepared in a far better manner in case there is a Covid wave as states have also their own lessons from the previous two waves.

"We are now hopefully getting past our (Covid-19) pandemic... and the economic activities will be strengthened as we get into the second half of this (fiscal) year given what I have seen for example various indicators, including the mobility indicators," Kumar told PTI in an interview. ## GST probe busts firms for 'fake' input tax credit invoices worth Rs 91 cr

GST officers have busted a network of 23 entities involved in creation of fake invoices worth Rs 551 crore and passing inadmissible input tax credit worth Rs 91 crore.Based upon specific intelligence, the officers of the anti-evasion branch of Central Goods and Service Tax (CGST) Commissionerate, Delhi (West) have unearthed a case of availment/utilization and passing on of inadmissible input tax credit (ITC) through goods less invoices of about Rs 91 crore, the Finance Ministry said in a statement.

The firms involved in this network are M/s Girdhar Enterprises, M/s Arun Sales, M/s Akshay Traders, M/s Shree Padmavati Enterprises and 19 others. These 23 firms were floated in order to generate goods-less invoices with an intent to pass on fraudulent ITC without paying actual GST to the government.

## India reports 41,506 cases on Sunday

India reported 41,506 daily Covid-19 cases on Sunday, with 895 deaths in the last 24 hours till 8:00 AM, as per the Health Ministry data. While many countries like UK, Russia, Australia and Bangladesh are dealing with the resurgence in daily infections, in India the cases seem to be under control with daily infections being less than 50,000 for 14 days continuously. A decline in total active caseload was noticed on Sunday at 4,54,118 and the cumulative death toll stood at 4,08,040, with India being third in the world behind the US and Brazil.

## Govt extends deadline for transaction, legal advisors to bid for managing IDBI Bank sale till Jul 22

The government has extended the deadline for transaction and legal advisors to bid for managing the IDBI Bank strategic sale by 9 days till July 22. The Department of Investment and Public Asset Management (DIPAM) had on June 22 invited bids from merchant bankers and law firms for managing and giving legal advice for the sale process. The last date to put in bids was July 13. "The competent authority has decided to extend the bid submission date of the tender by nine days. The last date of bid submission will now be July 22, 2021," the DIPAM said in a notice. ## FPIs pull out Rs 2,249 crore from Indian equities in July so far

After a month of net inflows, foreign portfolio investors (FPIs) pulled out Rs 2,249 crore from the Indian equities segment in the first seven trading sessions of July. This could be largely attributed to profit booking by FPIs with markets trading near all-time highs and investors choosing to stay on the sidelines, said Morningstar India Associate Director (Manager Research) Himanshu Srivastava. V K Vijayakumar, chief investment strategist at Geojit Financial Services, said it was important to appreciate the fact they are not selling big. "This is because even though valuations are stretched, there are no signs of a major crash in markets. The sharp dip in the US 10-year bond yield to around 1.3 per cent has again tilted the market in favour of equity," he said.

### Khadi brand gains strength globally as KVIC secures trademark registrations in these countries

In order to further strengthen and protect the word mark and brand 'khadi' globally, Khadi and Village Industries Commission (KVIC), the statutory body for the promotion of enterprises in khadi and village industries under the Ministry of MSME, has secured 'khadi' trademark registrations in three more countries – Bhutan, UAE, and Mexico. The trademarks were secured in Mexico in December last year followed by UAE on June 28, and Bhutan on July 9. According to the MSME Ministry, applications for similar trademarks have been pending in 40 other countries including the USA, Qatar, Sri Lanka, Japan, Italy, Australia, New Zealand, Singapore, Brazil, etc.The total number of countries where the Khadi trademark has been secured has gone up from six viz., Germany, the UK, Australia, Russia, China, and EU to nine now. According to the government, KVIC has got registrations in these countries in various classes that pertain to Khadi fabric, Khadi readymade garments and village industry products such as Khadi soaps, Khadi cosmetics, Khadi incense sticks, and more.

#### E-commerce exploitation through e-retailers' unethical practices forced lakhs of shops to close: CAIT

The exploitation of e-commerce channel through unethical business practices of online retailers in India has led to lakh of shops being forced to close, traders' body Confederation of All India Traders (CAIT) said on Sunday urging Commerce Minister Piyush Goyal to roll out the e-commerce policy immediately. "They (e-commerce companies) are trying to create a false narrative that (draft e-commerce) rules are stringent, will increase compliance burden, will discourage FDI in India, and malign the image of India in the global market," BC Bhartia, National President and Praveen Khandelwal, Secretary General, CAIT jointly said in a statement. The government had last month proposed amendments to Consumer Protection (E-commerce) Rules that indicated stricter compliance for e-commerce companies such as Amazon, Walmart-owned Flipkart, and others. The marketplaces have been continuously questioned by CAIT against their alleged business malpractices. The Ministry of Consumer Affairs, Food & Public Distribution, announcing the proposed changes, had categorically noted that that there was an "evident lack of regulatory oversight in e-commerce which required some urgent action".

## India's coal import rises 20 pc in May; volumes may be subdued in monsoon

India's coal import rose 20.4 per cent to 19.92 million tonnes (MT) in the month of May. The country had imported 16.54 MT of coal in May last fiscal, according to data compiled by mjunction Services.

"On a year-on-year basis, however, India's coal and coke imports in May 2021 were up 20.4 per cent as against 16.54 MT clocked in May 2020," it said.Import volumes of dry-fuel, it said, are expected to remain subdued in the ongoing monsoon season on account of lower demand, firm prices and high freight rates.India's coal import also rose 25.4 per cent to 42.19 MT in the first two months of the ongoing fiscal, against 33.63 MT of coal imported in the corresponding period of previous financial year, it said.

## India's power consumption rises 18 pc to 30.33 BU during July 1-7

India's power consumption grew nearly 18 per cent in first week of July to 30.33 billion units (BU) compared to a year ago and returned to pre-pandemic level mainly due to easing of lockdown curbs and delayed monsoon, according to power ministry data.

Power consumption during July 1-7 last year was 25.72 BU.Power consumption was recorded at 26.63 BU in first week of July in 2019. Thus, consumption of power has not only grown year-on-year but also returned to pre-pandemic level.In July 2020, power consumption recovered to 112.14 BU, but remained lower than 116.48 BU in the same month of 2019 (pre-pandemic level).

# Can BPCL get domestically produced LPG after privatisation, govt seeks legal opinion

A two-decade-old LPG supply order restricting supply of domestically produced LPG to only state-owned oil companies has stymied plans to allow Bharat Petroleum Corporation Ltd (BPCL) to continue selling subsidised cooking gas (LPG) after its privatisation.

A legal opinion has now been sought to ascertain if privatised BPCL will be eligible to receive liquefied petroleum gas (LPG) produced by companies such as ONGC and GAIL, two government officials with knowledge of the development said. Currently, BPCL has more than 8.4 crore domestic LPG customers, including 2.1 crore Ujjwala customers. # Chhattisgarh rural households to have tap water connection by 2023: Baghel

All 39 lakh rural households in Chhattisgarh will have access to pure drinking water through tap connection by 2023, state Chief Minister Bhupesh Baghel said on Sunday.In the 19th edition of his monthly radio address programme 'Lokvaani', Baghel spoke on New Era of Development and gave a detailed account of development and welfare initiatives being taken in the state, a government statement said.We have started a major campaign through 'Jal Jeevan Mission', under which pure drinking water will be supplied through tap connection to all 39 lakh rural households by the year 2023," the release quoted the chief minister as saying in the recorded address.Earlier, the target was to supply 40 litres of pure drinking water per person a day, which has now been increased to 55 litres per person a day. Ladakh first Union Territory to achieve 100% first dose coverage

Ladakh has become the first Union Territory to vaccinate all residents and the 'guest population', consisting of migrant labourers, hotel workers and Nepalese citizens who are earning their livelihood here, with the first dose of Covid-19 jab, administration officials said. In spite of Ladakh's low population, this is no mean feat in view of the region's challenging terrain, extreme weather and isolated centres of population — many of which are difficult to access. According to official data, a total of 89,404 people from all eligible age groups, including 18-44 years, have been administered the first dose of Covid vaccine. The second dose has been administered to 60,936 people. This was done in less than three months of starting the third phase of vaccination, covering the 18-44 age group. A total of 6,821 Nepalese citizens living in the UT were among those vaccinated.

# India's most purchased drugs in the last decade are for cardiac ailments, diabetes

Cardiac medication has emerged as the highest-selling drug therapy in India over the past one decade, while antidiabetics drugs have catapulted to among the top five therapies sold in India during this period. What makes this surge stark is that anti-diabetes drugs were not even among the top-five selling therapies till 2011, and cardiac drugs till the beginning of the millennium. At around Rs 21,000 crore annually, cardiac medication forms the biggest therapy of drugs being bought by Indians today. A decade ago, it was a third of its size and the second largest-therapy by sales. At around Rs 16,000 crore, anti-diabetes medication today is the fourth-largest therapy of drugs sold in the country, posting the maximum and an unfortunate surge among the leading therapies.

### Indian tea exports likely to fall nearly 15 per cent in 2021

The tea industry is bracing for a decline in exports to the tune of 30-40 million kg this year as compared to 2020, due to the availability of low-cost varieties in the global market and amid trade restrictions in countries that have traditionally been strong importers, industry sources said.

The coronavirus-induced economic downturn in much of the world is also a factor for falling shipments, they said. For the period between January to March this year, exports fell by 13.23 per cent as against the corresponding period a year ago, and by 29.03 per cent compared to 2019, as per Tea Board India data. Altogether, 45.86 million kg tea was

exported from India between January to March in 2021. The figure was 52.85 million kg in 2020 and 64.62 million kg in 2019.
