Key Developments

PM Modi to visit US from Sept 22-26; Quad, UNGA, talks with Biden on agenda

Prime Minister Narendra Modi and US President Joe Biden are expected to deliberate on ways to bolster bilateral ties in trade, investment and defence and security in their in-person talks in Washington on September 24, Foreign Secretary Harsh Vardhan Shringla said on Tuesday. He said Modi will leave for the US on Wednesday and will return on Sunday. The prime minister's delegation will include External Affairs Minister S Jaishankar, National Security Advisor Ajit Doval and Foreign Secretary Shringla among others. At a media briefing, Shringla said the bilateral talks between Modi and Biden are expected to figure ways to deal with radicalisation and terrorism besides major regional issues. The developments in Afghanistan are also likely to come up during the meeting. Prime Minister Modi will also meet US Vice President Kamala Harris. Besides holding bilateral talks with the US leaders, the prime minister will participate in the first in-person summit of the Quad in Washington on September 24 that is expected to broadly focus on contemporary global and regional issues.

Govt may offer pre-pack insolvency resolution plan even for large firms

To quicken the pace of stressed asset resolution, the Centre may soon come up with a prepackaged insolvency framework under the Insolvency and Bankruptcy Code (IBC) for large corporates, similar to the one introduced for SMEs.Official sources said that discussion on having a pre-packaged resolution framework for all categories of debtors is being discussed at the highest level and a decision may be taken once state owned bad bank -- National Asset Reconstruction Co. Ltd (NARCL) -- is operationalised. In April, Government operationalised pre-packaged insolvency resolution (PIRP) framework for MSMEs that is based on the 'debtor-in-possession' model which involves a resolution professional monitoring the entire process to ensure transparency.

Govt amends ammonium nitrate rules; introduces fire-fighting provisions

The government has amended the rules for ammonium nitrate to curb its pilferage, introduce fire-fighting provisions as well as improve ways to handle and store the chemical in the light of lessons learnt from the deadly Beirut explosion that killed about 140 people. Nearly 3,000 tons of ammonium nitrate was stored at Beirut's port for six years that detonated in August 2020, wreaking death and destruction. Additional Secretary in the Department for Promotion of Industry and Internal Trade (DPIIT) Sumita Dawra said that rules pertaining to five major areas -- static and mobile pressure vehicles, calcium carbide, ammonium nitrate, gas cylinders, and petroleum and explosives -- were examined in the light of lessons learnt from ammonium nitrate explosion in Beirut. There was a need to look at the rules to enhance safety, so that such incidents do not happen in India, she said. She said that to curb pilferage of ammonium nitrate, provisions have been made to import the chemical in bagged form only, as this will help in reducing the handling of loose chemicals at ports and enhance safety.

GST panel to consider giving waiver on 1 day interest, late fee

As some taxpayers faced difficulties in filing GST return on Monday, the tax department on Tuesday said the IT grievance redressal committee would consider giving interest and late fee waiver. The Central Board of Indirect Taxes and Customs (CBIC) in a tweet said a few taxpayers have reportedly faced difficulty in updation of Electronic Cash Ledger on September 20. September 20 was the last day for filing GST returns and paying taxes via GSTR-3B for August. "To mitigate their difficulties, GSTN has been directed to take up the issue of waiver of late fee and interest for one day for such taxpayers, before the IT Grievance Redressal Committee," the tweet said.

Nomura India Business Resumption Index plateaus in September

The Nomura India Business Resumption Index eased to 100.6 for the week ending September 19 from 101.4 the prior week, although still above its pre-pandemic level of 100. While mobility continued to improve despite mixed indicators, other economic indicators such as e-way bills and rail freight remained uneven. "We expect GDP growth to rebound to 5.0% q-o-q, sa, in Q3 (July-September; 7.3% y-o-y from 20.1% in Q2) and FY22 GDP growth to average 9.2% y-o-y," analysts at Nomura Global Market Research said in a note Tuesday.

India witnessing consumption revival; spending on discretionary increases: Deloitte report

Indians are slowly making their way back to the office and is witnessing a consumption revival in the country with spending intent shifting towards more discretionary items, according to a report by global consultancy and advisory firm Deloitte. After witnessing two waves of the pandemic, India is "cautiously returning" to a state of "business as usual", said the Deloitte's Global State of Consumer Tracker.

At 17%, fresher hiring sentiment is highest in India: TeamLease study

Fresher hiring intent is highest in India, at 17 per cent, compared with the global sentiment, which hovers at six per cent. A 'Career Outlook Report' by TeamLease EdTech for the period July to December 2021 across 18 sectors and 14 cities, indicates that 17 per cent employers are keen to hire freshers in H2 2021. From a sector perspective, emerging sectors that have withstood the impact of the pandemic and have had a stronger hiring sentiment are information technology (31 per cent), telecommunication (25 per cent) and tech startups (25 per cent). Other sectors that have been faring well are healthcare & pharma (23 per cent), logistics (23 per cent) and manufacturing (21 per cent). From a location perspective, the leading cities for freshers hiring are Bengaluru (43 per cent), Mumbai (31 per cent) and Delhi (27 per cent), Chennai (23 per cent) and Pune (21 per cent).

Retail depositors earning negative returns; relook taxes on interest: SBI

Retail depositors are earning negative returns on their bank deposits and hence, there is a need for reviewing taxes on interest earned, economists at the country's largest lender SBI have said. If not for all the depositors, the taxation review should be carried out for at least the deposits made by senior citizens who depend on the interest for their daily needs, the economists led by Soumya Kanti Ghosh said in a note, which pegged the overall retail deposits in the system at Rs 102 lakh crore. At present, banks deduct tax at source at the time of crediting interest income of over Rs 40,000 for all the depositors, while for senior citizens the taxes set-in if the income exceeds Rs 50,000 per year. As the policy focus has shifted to growth, the interest rates are going down in the system which pinches a depositor. "Clearly, real rate of return on bank deposits has been negative for a sizeable period of time and with RBI making it abundantly clear that supporting growth is the primary goal, the low banking rate of interest is unlikely to make a north bound movement anytime soon as liquidity continues to be plentiful," the note said.

India plan for tighter e-commerce rules faces internal govt dissent: Report

India's plan to tighten rules on its fast-growing e-commerce market has run into internal government dissent, memos reviewed by Reuters show, with the Ministry of Finance describing some proposals as "excessive" and "without economic rationale". The memos offer a rare glimpse of high-stakes policy-making governing a market already featuring global retail heavyweights from Amazon to Walmart, plus domestic players like Reliance Industries and Tata Group. The sector is forecast by Grant Thornton to be worth \$188 billion by 2025. It's not clear how the objections from the finance ministry - a dozen in total - will ultimately be reflected in the proposed rule changes, first floated in June.

Medical oxygen output capacity rises to over 8,000 tonnes a day from 6,000 tonnes last year: Official

The production capacity for liquid medical oxygen, which was in huge demand during the second wave of the COVID-19 pandemic in the country, has increased to over 8,000 tonnes per day now, from 6,000 tonnes per day last year, a senior government official said on Tuesday. Additional Secretary in the Department for Promotion of Industry and Internal Trade (DPIIT) Sumita Dawra said the supply of oxygen for medical purposes was enhanced almost 10 times from 1,000 tonnes per day in December 2019 to 9,600 tonnes per day in May this year. "Our production capacity today has increased from 6,000 tonnes last year to over 8,000 tonnes today," she told reporters.

Sivakasi, fireworks hub keeps fingers crossed as Delhi bans bangers

Days ago, the Delhi government banned sale, use, storage of firecrackers for the festival of lights over pollution concerns."What is the basis of Delhi government's ban?, we were allowed to manufacture and now suddenly they have come up with this decision," says President of Tamil Nadu Fireworks and Amorces Manufacturers Association (TANFAMA), P Ganesan questioning Delhi's rationale. The production is in strict compliance with government norms and by following Supreme Court's directives including those related to green crackers, he says. Last year, following the first wave of the COVID-19 pandemic, states including Rajasthan and the Delhi government banned fircrackers. At least seven states including Rajasthan and Delhi have unsold stocks worth crores and "we request the Delhi government and all others to allow use of firecrackers as per norms on Deepavali for two hours," the TANFAMA chief told PTI.

Include nursing, engineering diploma holders under Minimum Wages Act: CEAI

Engineering professionals' body CEAI on Tuesday said it has urged the government to include paramedical, nursing and engineering diploma holders under the Minimum Wages Act."The prevalent Minimum Wages Act in the country covers and protects only skilled and semi-skilled workers, including drivers, office boys and industrial workers only," the Consulting Engineers Association of India (CEAI) said in a statement. In a letter written to the Union labour and employment ministry as well as the Delhi government, K K Kapila, chairman of CEAI's business and policy committee, has urged them to include paramedical, nursing and engineering diploma holders under the Minimum Wages Act, the statement said. CEAI, which has about 300 members, represents the Indian engineering consultancy professionals at the International Federation of Consulting Engineers."

Kharif foodgrain output estimated at record 150.50 mn tonne this year: Govt

India's foodgrain production is likely to touch record 150.50 million tonne in the ongoing kharif season on better rice output amid good monsoon, the agriculture ministry said on Tuesday. In the kharif season of 2020-21 crop year (July-June), the foodgrain output comprising rice, pulses and coarse cereals stood at a record 149.56 million tonne. Record production is pegged in rice, sugarcane and cotton. However, production of coarse cereals and oilseeds is estimated to be lower marginally during the kharif season of this year. Sowing of kharif (summer) crops like paddy begins with the onset of the Southwest monsoon from June, while harvesting in most of the parts commences from October. Releasing the first advance foodgrain production estimate for the ongoing kharif season, Agriculture Minister Narendra Singh Tomar said: "A record foodgrain production is estimated at 150.50 million tonne in kharif season." Bumper crop is being achieved on account of tireless hard work of farmers and scientists besides farmer-friendly government policies, he said.

Himachal Apple growers demand govt support as farm-gate prices fall to a 10-year low

Resentment is brewing among apple growers of Himachal Pradesh as farm-gate prices of the fruit fall to a 10-year low, stoking demand for federal intervention and policy support to make the business viable. Orchard owners have asked the Centre to implement the Kashmir formula in Himachal as well to cushion cultivators from a price shock. New Delhi, through the National Agricultural Cooperative Marketing Federation (NAFED), buys apples from Kashmiri farmers at Rs 60, Rs 44 and Rs 24 per kg, depending on output quality.

New Leh airport terminal likely to become operational by Dec 2022: Govt

The new airport terminal in Leh is likely to become operational by December next year, Civil Aviation Minister Jyotiraditya Scindia said on Tuesday. This was conveyed by Scindia to Ladakh Lieutenant Governor R K Mathur during a virtual meeting with him to discuss the progress of ongoing and new civil aviation projects for better air connectivity in the region. "The new airport terminal at Leh may become operational by December 2022, the aviation minister said. He also agreed to the construction of a civil enclosure at Thoise airport, considered the air lifeline to the world's highest and coldest battlefield, by the Airports Authority of India (AAI) once land is made available. Scindia noted that a team will shortly visit Ladakh to technically evaluate locations for additional airstrips in Leh. He agreed to look at the possibility of operationalising commercial flights with smaller jet planes to Kargil as an interim solution. India adds record high rooftop solar capacity of 521 MW in April-June

India has added 521 MW of rooftop solar capacity in April-June this year, which is the highest capacity installed in a quarter, according to Mercom India report. India added 521 megawatts (MW) of rooftop solar capacity in the second quarter (Q2) of the calendar year (CY) 2021, a 53 per cent increase quarter-on-quarter (QoQ) compared to 341 MW installed in Q1 2021 (January-March), said Mercom India Research's newly released Mercom India Rooftop Solar Market Report Q2 2021. Rooftop solar installations were up 517 per cent year-over-year (YoY) compared to the 85 MW installed in Q2 2020 (April-June 2020). Rooftop solar capacity additions in India in Q2 2021 (April-June) were the highest in a quarter. As per the report, installations were significantly higher than the previous quarter despite the second wave of the COVID-19 and related state lockdowns.

India's fuel ethanol consumption to rise to meet E20 target: Fitch

Fitch Solutions said on Tuesday that India's ethanol consumption will increase over the next few years, driven primarily by the government's desire to support the sugar sector by boosting ethanol production but also because of the recovery in road travel following Covid-19 disruptions. At the same time, demand for industrial ethanol is also likely to rise in coming years in tandem with the expansion of its domestic chemical and healthcare sectors. The government is targeting a motor fuel blending rate of E10 (10:90 ethanol:gasoline) by 2022 and brought forward its ethanol E20 target to 2023 (from 2025) in June earlier this year. This is the second time this year that the E20 target has been brought forward, which indicates how important the issue to the government. If the E20 target was to be met in 2025, this will require 9 billion litres of ethanol by 2025 (7.5 billion for motor fuel, 1.5 billion for industrial use), about 6.3 billion litres more than currently produced domestically.

UP govt to set up 'Electronic Park' near Noida

After Toy Park, Film City, Medical Device Park and Leather Park, the Uttar Pradesh government is gearing up to develop an 'Electronic Park' for electronic devices and accessories along the Yamuna Expressway near Noida, officials said on Tuesday. The park is expected to attract an investment of Rs 50,000 crore and will provide employment to thousands of local youths, according to Arun Vir Singh, the CEO of the Yamuna Industrial Development Authority (YEIDA). Indian government won't buy Pfizer, Moderna vaccines amid local output, sources say

India's government will not buy COVID-19 shots from Pfizer/BioNTech and Moderna, three government sources told Reuters, mainly because domestic output of more affordable and easier-to-store vaccines has jumped. That essentially means the globally popular vaccines, which their makers have pledged not to sell to private parties during the pandemic, will not be available for now in the world's two most populous countries - China and India. Serum Institute to supply nearly 22 crore doses of Covishield vaccine to Centre in October

The Serum Institute of India has informed the Centre that it will be able to supply around 22 crore doses of Covishield in October as the Union government has announced resuming export of surplus Covid vaccines in the coming fourth quarter under the 'Vaccine Maitri' programme, official sources said. In a communication to the Centre on Monday, Prakash Kumar Singh, Director, Government and Regulatory Affairs at Serum Institute of India (SII), said the firm has enhanced its production capacity of Covishield and it will be able to supply 21.90 crore doses in October to Government of India and private hospitals. The Pune-based pharmaceutical company has enhanced the manufacturing capacity of Covishield to more than 20 crore doses per month."Starting from January 2021, we have supplied 66.33 crore doses of Covishield to MoHFW, Government of India in addition to supply of more than 7.77 crore doses to state governments and private hospitals till 19th September 2021 evening.

Nurse to doctor ratio in India estimated to be 1.7:1 on basis of NSSO data: Report

The nurse to doctor ratio in India is estimated to be 1.7:1 on the basis of NSSO data, while the ratio of allied health workers to doctors is estimated to be 1:1, according to a report by the WHO and the Public Health Foundation of India. Although there was no standard skill-mix ratio of different health workers, most OECD countries reported approximately 3-4 nurses per physician, the report stated. The Indian High Level Expert Group (HLEG) recommendation for the nurse-doctor ratio in India stood at 3:1, it said. Moreover, there was also a need to strike a balance (right skill-mix) between doctors and allied health workers, it added.

Covid-19 vaccines safe, effective for cancer patients, studies find

People with cancer have an appropriate, protective immune response to COVID-19 vaccines without experiencing any more side-effects than the general population, researchers said on Tuesday. Evidence presented virtually to a global audience at the annual congress of the European Society for Medical Oncology (ESMO), suggests that a third "booster" shot could further increase the level of protection among this patient population. Patients with cancer were excluded from the clinical trials conducted to develop the COVID-19 vaccines and support their authorisation for use. The questions of whether the vaccines are safe in this vulnerable population and whether they provide adequate protection against severe forms of COVID-19 to individuals whose immune system may be weakened by various anticancer medicines had until now been left open.

"The fundamentals of SME business in these South Asian countries are similar; they are all export oriented, they suffer from the same problem of lack of funding, so the same model can be easily replicated," he said.
