### MoSPI gears up for 80th national sample survey

The Ministry of Statistics and Programme Implementation (MoSPI) would soon start work on the 80th round of the national sample survey, people in the know told ET, amid an increasing focus on the quality of survey data. ET reported last month that the 79th round of the National Sample Survey was due to be completed this month, and that the results would likely be available by December-end. "Some of the indicators are likely to be repeated this year as well," one of the people said. ### Outbound travel witnesses a 22 per cent hike y-o-y: MoT

Indians are emerging as big globetrotters and outbound travel is seen crossing even pre-Covid levels. As many as 22,32,313 Indian nationals departed on oubound travel in July 2023 as compared to 18,30,798 in July 2022, registering a growth of 22 per cent. At the same time in 2019, 21,80,437 Indians departed on outbound travel. Departures during January-July, 2023 stood at 1,54,41,150 as compared to 1,11,92,191 in the same period in 2022, registering a growth of 37.9 per cent. For the January-July 2019, the figures stood 1,55,60,516, according to a report by the Ministry of Tourism(MoT).

### RBI likely to keep interest rate unchanged as inflation still high: Experts

The Reserve Bank is likely to maintain status quo on policy rates for the fourth time in a row at its bi-monthly monetary policy review meeting early next month, as retail inflation continues to remain high and the US Federal Reserve has decided to keep a hawkish stance for some more time, according to experts. "We do expect the RBI to hold on to a status quo position this time as inflation is still high and liquidity tight. In fact, going by RBI forecast on

Around 30 out of 40 applicants are expected to qualify for Rs 17,000-crore production linked incentive scheme for IT hardware, according to a government official. ### Electronics sales seen growing 20% this festive season

The appliances and consumer electronics industry expects around 18-20% value-driven growth this festive season which is coinciding with the Cricket World Cup. TV makers, including LG Electronic, Panasonic and Thomson, expect increased number of replacements of conventional and small-size TV screens with large-size smart TV panels above 55-inch screen size. Premium and ultra-premium ranges of QLED and OLED TVs are also expected to be in much demand during the World Cup from October 5 to November 19. The industry expects overall sales growth of 18 to 20%, and in continuation of the previous year a higher growth of over 30% from premium products such as large screen TVs, higher capacity refrigerators and washing machines.

State-run ports seek oil spill centres, immigration facility

An immigration facility at the Puducherry port, regional oil spill response centres in five states and removing submarine oil and gas pipelines in Mumbai are among the requests from state maritime boards that are being considered by the Centre. Most state government-controlled maritime boards want improved support for their ports along with better facilities to help them gain more cargo and passenger volumes. "Calls for financial incentive to encourage shift of cargo from road or rail to coastal shipping also figure on the list of demands," a top government official aware of such requests told ET. Meanwhile, the Centre has flagged some concerns. "A critical issue regarding statutory compliance for ports was raised. Many stateor union territory-run ports (also called non-major ports) have not obtained compliance certificates of navigational safety. In some cases, clearance from the Petroleum and Explosives Safety Organisation was also lacking," the official said, adding that all maritime states and union territories have been asked to speedily rectify this.

#### Diesel, ATF and fuel oil pull up petroleum products exports by 9% m-o-m in August

India's exports of refined petroleum products rose by almost 9 per cent m-o-m to 5.83 million tonnes (mt) in August largely supported by outbound shipments of diesel, aviation turbine fuel (ATF) and fuel oil. According to the Petroleum Planning and Analysis Cell (PPAC), petroleum products exports last month were the highest in FY24 and the second highest in the current calendar year.

### Madhya Pradesh auctions 22 mineral blocks, to earn Rs 38,100 crore

Out of the 51 mineral blocks offered for auction by Madhya Pradesh's Mining Department, 22 have been successfully auctioned, including four blocks of critical minerals. According to the department estimates, these auctions will generate a revenue of Rs 38,100 crore. This latest round brings the total number of blocks auctioned in the state to 68, the highest in the country.

## Himachal govt to provide collateral-free loan to small-scale enterprises

The Himachal Pradesh government on Saturday announced the launch of a scheme to offer collateral-free loans to small-scale enterprises and skill-based workers such as cobblers, tailors, barbers and vegetable vendors. The state government has earmarked Rs 40 crore for the Mukhya Mantri Laghu Dukandar Kalyan Yojna (MMLDKY) and said that it will target the inclusion of 75,000 individuals falling in the 18-55 age bracket in its initial phase, a statement issued here on Saturday said.

#### ICMR worried over rising resistance to last-resort antibiotics in India

A latest study by the Indian Council of Medical Research (ICMR) has found that the resistance to last-resort antibiotics is rising in India, Tol reported on September 24. ICMR has found the abuse of antimicrobials (antibiotics, antivirals or antifungals) to be the reason for this, which is says has led to widespread resistance among people. The study was based on data from 21 tertiary-level hospitals across India. For example, carbapenem, an antibiotic that effectively treated pneumonia and septicemia until a decade ago, may not help Indian patients anymore. According to the report, if eight out of 10 patients with a drug-resistant E-coli infection responded to carbapenem in 2017, only six responded in 2022.

#### India to delay import licensing of laptops after US, industry push back-sources

India's electronics ministry is now proposing a simpler import registration process that is due to start in November, said the officials, who have direct knowledge of the discussions. A representative for India's IT ministry did not immediately respond to a request for comment. The new 'imports management system' will need companies to obtain 'registration certificates' for imports of laptops, tablets and personal computers, instead of licences proposed earlier by the Aug.3 order, one of the officials said. The ministry conveyed the proposal to industry officials in a meeting on Friday, they added. ## DGTR suo-motu probing alleged dumping of three Chinese goods; to protect MSMEs from cheap imports

The commerce ministry's investigation arm DGTR has "suo-motu" initiated probes against alleged dumping of three products, including unframed glass mirrors and fasteners, by Chinese companies as the authority seeks to guard MSME units against cheap imports from the neighbouring country. Usually, anti-dumping investigations are initiated based on an application filed by domestic producers, but since the fragmented industries did not have the know-how of the procedures involved in the trade remedy probe, the Directorate General of Trade Remedies (DGTR) has undertaken the exercise to investigate the matter on its own initiative.
