Domestic demand to sustain India growth in the near term, says Moody's

Strong domestic demand is likely to sustain India's economy in the near term, said Moody's on Thursday as it kept the country's growth forecast for 2023 and 2024 unchanged at 6.7 and 6.1 per cent. "Robust goods and services tax collections, surging auto sales, rising consumer optimism and double-digit credit growth suggest urban consumption demand will likely remain resilient amid the ongoing festive season," said the rating agency's 'Global Macro Outlook 2024' report.

The pace of India's consumer price inflation likely eased further to a four-month low of 4.80% in October, closer to the Reserve Bank of India's 4% medium-term target, according to a Reuters poll. India vulnerable to recurring food price shocks, says RBI Governor Das

Reserve Bank of India (RBI) Governor Shaktikanta Das on Thursday said India remains vulnerable to "recurring and overlapping" food price shocks despite the recent moderation in inflation. In these circumstances, monetary policy remains watchful and actively disinflationary to progressively align inflation to the target, while supporting growth, Das said at a symposium on the Indian economy organised by the Institute of Indian Economic Studies in Tokyo in Japan.

In a letter to industry and retail associations and manufacturers of white goods, Rohit Kumar Singh, secretary to the government, has advised them to revise the policy of warranty to reflect its commencement from the date of installation rather than the date of purchase.

India weighs changes to improve production incentive schemes: Report

India is planning to ease and expand some norms for five sectors to help them better utlise its \$24 billion industrial incentives aimed at boosting local manufacturing, two government officials said on Thursday. The 1.97-trillion rupees production-linked incentive scheme (PLI), launched in 2020, covers 14 sectors ranging from electronic products to drones but has been successful only in a handful of them, triggering reviews. The changes are being planned in the textiles, pharmaceuticals, drones, solar and food processing industries, which together form nearly a third of the PLI scheme. The government plans to include more products in the textile sector such as man-made fibre and give firms an additional year to meet the manufacturing targets required to claim incentives for the scheme, the officials said.

FMCG sales pick up on festival boost in October, shows Bizom data

Sales of fast-moving consumer goods (FMCG) saw an uptick in October as kiranas, or mom-and-pop stores, stocked up ahead of Diwali, according to the data by retail intelligence firm Bizom. Rural growth, which had been muted until recently, witnessed a strong revival last month. "There was a strong double-digit growth in rural sales across FMCG categories excluding branded commodities. This was driven by high growth in confectionery, beverage, and packaged foods as gift packs saw greater traction," Akshay D'Souza, chief of growth and insights at Bizom, told Business Standard.

Jewellers cautiously optimistic about gold demand this Dhanteras; expect 10pc rise in sale

New Delhi: Jewellers are cautiously optimistic about gold demand on the Dhanteras day on Friday and expect a 10 per cent increase in gold jewellery and bullion sales amid a sharp rise in gold prices in view of geopolitical developments. Gold prices have shot up by more than 20 per cent since last Dhanteras to nearly Rs 61,000 per ten grams. Gold prices in Delhi were ruling at Rs 50,139 per ten grams, excluding taxes, on last year's Dhanteras, while at Rs 47,644 on 2021 Dhanteras festival. "There is an 8-10 per cent annual rise in gold prices. And people have accepted the base price of gold at Rs 58,000 per ten grams. We are expecting 10 per cent increase in sales volume this Dhanteras from over the last year," All India Gems and Jewellery Domestic Council Chairman Saiyam Mehra told PTI.

India's fuel consumption rises 9.3% in October to 19.2 million tonne

Fuel consumption in India, a proxy for oil demand, rose 3.4 per cent on an annual basis in October, data released by the Petroleum Planning and Analysis Cell (PPAC) has shown. On a sequential basis, consumption increased by 5.4 per cent. Consumption of fuel hit 19.2 million tonnes (mt) in October, up from 18.2 mt in the same month last year. Sales of diesel, the most used fuel in the country, rose 9.3 per cent to 7.63 mt in October. Sales had reached an all-time high of 8.21 mt in May.

Import of cheaper solar modules on rise as China exploits loopholes

Indian solar panel manufacturers are grappling with the influx of cheaper Chinese imports funnelled through intermediary countries such as Vietnam, Malaysia, and Singapore as Chinese companies exploit Free Trade Agreement (FTA) loopholes to export to India. Work commitments of city gas companies may be regularised

The Petroleum and Natural Gas Regulatory Board (PNGRB) may rationalise the minimum work programme (MWP) commitments city gas companies made in the previous years, which would push companies with lower commitments to raise household gas connection targets while bringing relief to firms that promised high targets but are now facing penalties for missing those "PNGRB over the last 15 years has had an ever-evolving regime for the minimum work programme commitments," PNGRB chairman Anil Kumar Jain told ET. In the first and second city gas licensing rounds, MWP commitments were 20-30% of total households in a licences area with an understanding that if so many households were connected by the distributor, others would automatically follow, he said. "In the rounds that followed, MWP commitments got extremely diluted to less than even 10% of the nu ...

Improvements in trade receivables of power utilities expected: Fitch

Fitch Ratings on Thursday said it expects improvement in trade receivables of power utilities, particularly from weaker state-owned distribution companies (discoms), and the pace of capital expenditure (capex) to be the key credit drivers for rated power utilities in the near to medium term. Indian power utilities have seen improvements in their receivables over the past two years, especially since the implementation of the late payment surcharge rules in June 2022. The average receivable days of seven Indian power utilities have fallen to 85 in FY23 from 142 days in FY21, as per the ratings agency.

Power units with fuel linkage under Shakti plan get sales flexibility

Power plants that are given coal linkages under the Scheme for Harnessing and Allocating Koyala Transparently in India (SHAKTI) policy, can now sell electricity on segments other than day-ahead market (DAM) of the power exchanges. The government has made a change in the SHAKTI policy enabling plants that don't have power purchase agreements and get fuel through the scheme to sell electricity in any segment on the electricity exchanges. Through the policy change, such electricity can now also be sold in the term-ahead market (TAM) and the real-time market apart from DAM or through the Discovery of Efficient Energy Price (DEEP) portal. DPIIT to engage consultancy agency to draw reservation list for FTA talks

The department for promotion of industry and internal tarde (DPIIT) has proposed to engage a consultancy agency to draw a reservation list to be used during negotiations of a free trade agreement (FTA). The list deals with items which do not qualify for commitments under a trade agreement. The DPIIT, being the nodal department for formulation of FDI policy and investment screening, leads the negotiations on investment chapters within FTAs on non-services sectors. The chapter on investment liberalization is accompanied by a 'reservation list' which allows host countries to restrict the commitments to specific sectors/activities.

Commerce ministry panel reviewing guidelines for elections of EPCs, FIEO to submit report by month end

The commerce ministry's committee, which is reviewing the eligibility criteria for the election of office bearers of export promotion councils (EPCs) and apex exporters body FIEO, is expected to submit its report by end of this month, an official said. Forex reserves' import cover stood at 10.2 months as at June-end 2023: RBI report

India's foreign exchange reserves cover of imports (on balance of payments basis) increased to 10.2 months as at June-end 2023 from 9.6 months at end-March 2023. Import cover is a trade-based indicator of adequacy of reserves. This cover improved in sync with rise in forex reserves, which stood at \$595.051 billion as at June-end 2023 against \$578.449 billion as at March-end 2023.
