Wholesale price inflation soars to 2.37% in Dec; food prices see decline

India's wholesale price index (WPI) based inflation rose to 2.37 per cent in December from 1.89 per cent in November due to the rise in prices of manufactured items and a low base effect, according to the government data released on Tuesday. The WPI-based inflation stood at 0.86 per cent in December last year. But, inflation in food items declined slightly to 8.47 per cent in December from 8.63 per cent in November. This was led by deceleration in the prices of cereals (6.82 per cent), paddy (6.93 per cent), wheat (7.63 per cent) and pulses (5.02 per cent), according to data released by the Union Ministry of Commerce and Industry.

They highlighted the urgent need for BoCW welfare boards to diligently work for providing social security by strengthening registration machinery, API integration of data of BoCW boards with eShram by all states/UTs, extending social security benefits to ensure 100 per cent coverage like health, insurance, accidental benefits for all workers, besides leveraging technology to enhance the functioning of the welfare boards.

Al set to reshape 38 mn jobs in India by 2030, boost productivity: EY

Artificial intelligence (AI) adoption could transform 38 million jobs by 2030, driving a 2.61 per cent productivity boost to the Indian economy through gains in the organised sector and a potential for additional 2.82 per cent with the adoption of Gen AI by the unorganized sector, said a report. The report shows that 24 per cent of tasks across industries have the potential for full automation, while another 42 per cent can be enhanced through AI, freeing up between 8-10 hours per week for knowledge workers. At an industry level, the largest productivity gains are expected in the services sector due to its higher labour share to gross output while manufacturing and construction will see smaller impact.

Average salary hike in India projected to be 9.4% in 2025: Report

Indian employees may expect an average salary increment of 9.4 per cent this year across industries, indicating strong economic growth and rising demand for skilled talent, a report said on Tuesday. Over the last five years, salary increments have steadily increased, rising from 8 per cent in 2020, to a projected 9.4 per cent in 2025, according to Total Remuneration Survey (TRS) by HR consulting firm Mercer. The automotive sector leads with anticipated increments of 10 per cent from 8.8 per cent, driven by the surge in electric vehicles and the government-led 'Make

in India' initiative. Manufacturing and engineering follow closely with an increase from 8 per cent to 9.7 per cent, reflecting a resurgence in the manufacturing ecosystem.

Vision Document 2047: IMD aims for zero-error forecast up to 3 days

The India Meteorological Department (IMD), which celebrated its 150th anniversary on Tuesday, has targeted zeroerror weather forecasting up to three days, and 90 per cent accuracy in forecasting up to five days by 2047, a "Vision Document" released by Prime Minister showed. The document that maps current gaps in weather forecasting and merges the outcome with futuristic developments in science and technology, has also targeted zero loss of life for all types of severe weather events by enabling disaster managers, stakeholders, and the general public to take early action following early accurate warning. It has targets set for next two years, next 10 years, that is till 2035, and next 22 years, that is till 2047.

Insurance industry seeks tax incentives, Insurance Act amendment in Budget

The insurance industry is expecting amendments to the Insurance Act, along with additional tax exemptions for protection and health insurance products, as well as adjustments to the new tax regime, in this year's Union Budget to improve affordability and drive greater penetration and growth in the sector. The industry is also expecting capital infusion into state-owned general insurers to improve their solvency. According to industry insiders, amendments to the Insurance Act will bring a raft of changes, including opening the agency channel for insurers and changes to capital requirements for the companies. Moreover, the industry is expecting an increase in the foreign direct investment (FDI) limit to 100 per cent from the current 74 per cent.

Bank FD rates keep rising as war for deposits not over yet

Several Indian banks are increasing interest rates on fixed deposits to attract more customers amid a continuing liquidity crunch. IDBI Bank and Bank of Baroda are among the institutions offering new schemes with higher returns. Lending growth outpaced deposit growth in the final fortnight of 2024, continuing a trend where credit and deposits have not been moving in sync. Banks have struggled to raise enough deposits to meet rising credit demand. As of December 27, credit grew by 11.16% year-on-year, while deposits rose by 9.8%, according to the latest data from the Reserve Bank of India.

Big changes ahead for Indian carmakers on recycling steel

From April, automobile manufacturers must recycle at least 8% of steel used in vehicles sold in 2005-06. This increases to 18% by 2035-36. They must ensure safe collection and recycling of end-of-life vehicles. They need to purchase EPR certificates from scrapping facilities and create consumer awareness. There are currently 82 Registered Vehicle Scrapping Facilities in the country.

Fashion and beauty lead as tier-III cities drive e-commerce growth in 2024

India's e-commerce sector continued its robust growth trajectory in 2024, propelled by rising demand from smaller cities and an increased focus on omnichannel strategies, according to the Unicommerce 2024 Trends Report. The report, which analysed nearly 900 million transactions processed through the platform, said that fashion and accessories retained their position as the most significant category in terms of order volume, accounting for 29 per cent of all online purchases. Items like casual wear and western apparel emerged as the most sought-after products in 2024. Closely following was the beauty, wellness, and personal care segment, which constituted 20 per cent of the total orders.

Passenger vehicle dispatches hit record 4.3 million units in 2024

The passenger vehicle (PV) segment, which comprises cars, utility vehicles (UVs) and vans, posted a 4.2 per cent growth in 2024 calendar year (CY) to 4.3 mn units, the highest ever, riding on the back of SUV (sports utility vehicle) sales. UV sales were up by almost 17 per cent to 2.7 mn units while passenger cars dipped by 14.4 per cent to 1.37 mn units during the CY. "At the beginning of the year, Siam had forecast that the PV volume growth in 2025 would be 4-5 per cent due to high base effect. The final numbers are in line with the forecast," Partho Banerjee, senior executive officer, marketing & sales, Maruti Suzuki India Limited (MSIL), had told Business Standard in the first week of January.

Wheat sowing up 1.38% to 32 million hectare in 2024-25 rabi season

Wheat sowing increased by 1.38 per cent year-on-year to 320 lakh hectare so far in the ongoing 2024-25 rabi season, according to the agriculture ministry data released on Tuesday. Wheat, the main rabi (winter) crop, was sown in 315.63 lakh hectare in the year-ago period. Sowing of most rabi crops is nearing end. Harvesting will begin from April. According to the data, pulses' acreage remained flat at 139.81 lakh hectare as on January 14, compared to 139.11 lakh hectare in the year-ago period.

Gram was covered in 96.65 lakh hectare and lentil in 17.43 lakh hectare.

Indian aviation industry to see Rs 3,000 crore loss in FY25-26 amid supply chain woes: ICRA

India's civil aviation industry is forecasted to report a net loss of Rs 2,000 to Rs 3,000 crore in FY25 and FY26, according to a report by ICRA. Persistent supply chain disruptions and engine issues have constrained capacity over the last 18 months and are likely to persist. Despite these challenges, the sector is poised for moderate growth in domestic and international passenger traffic. ICRA projects domestic air passenger traffic growth to taper to 7-10

per cent in FY25, compared to 13 per cent in FY24, due to a high base effect and weather-related disruptions in the first half of FY25.

Centre notifies guidelines under 'PM-Surya Ghar Muft Bijli Yojana'

Union Ministry of New and Renewable Energy on Tuesday notified guidelines for implementation of 'payment security mechanism' component and 'central financial assistance' component for RESCO models under 'PM-Surya Ghar: Muft Bijli Yojana.' The scheme offers two alternative implementation models for the installation of rooftop solar plants for consumers: the RESCO (Renewable Energy Service Company) model, where third-party entities invest in rooftop solar installations, allowing consumers to pay only for the electricity consumed without bearing the upfront costs; and the Utility-Led Aggregation (ULA) model, where DISCOMs or state designated entities will install rooftop solar projects on behalf of individual residential sector households.

Telecom spectrum in 6-Ghz band key to avoid 5G radio wave crunch: COAI

Non-allocation of telecom spectrum in 6-Ghz band could lead to a radio wave crunch for high-speed 5G services, a key growth driver for the country's digital economy and development of emerging technologies specially artificial intelligence, industry body COAI said on Tuesday. India needs an additional 2 giga hertz of mid-band spectrum to meet the international standard of 'IMT-2020' user experience to ensure data rates of 100 megabit per second (mbps) on downlink and 50 mbps on uplink in densely-populated cities, COAI Director General S P Kochhar told PTI, citing global telecom industry GSMA.

PMO tells DoT to double down on mobile fraud

Rural development minister Shivraj Singh Chouhan set to allocate 821,000 houses in MP

Rural development minister Shivraj Singh Chouhan will on Wednesday allocate about 821,000 houses under the Pradhan Mantri Awaas Yojana - Gramin (PMAY-G) for beneficiaries in Madhya Pradesh. About ₹3,726 crore in central assistance has been released to the state so far this fiscal to ensure swift disbursement of the first installment to beneficiaries to start house construction, the ministry said in a statement on Tuesday. "Upon timely utilisation, an additional ₹4,934 crore may be released within the fiscal year," it added.

Healthcare Industry seeks tax cuts on insurance premiums & increased budgetary allocation in Budget 2025

Ahead of the Union Budget 2025, industry stakeholders are expecting reforms that will propel the healthcare sector. Medtech sector seeks standard GST rate, export incentives in Budget

The medical devices manufacturing sector has rolled out a robust wishlist for the upcoming Budget, with the standardisation of rates in the goods and services tax (GST), enhancement of export incentives, and monitoring of maximum retail price (MRP) for imported devices among the major demands. Commenting on the demands, Himanshu Baid, managing director, Poly Medicure, said that the government could consider standardising the GST rate at 12 per cent across all medical devices, as it would simplify the tax structure, ensuring consistency and ease of doing business. The industry has also asked the Centre to enhance export incentives under the Commerce Ministry's Remission of Duties and Taxes on Exported Products (RoDTEP) scheme to 2 to 2.5 per cent, up from the current range of 0.6 to 0.9 per cent.

Commerce ministry may seek 5-year extension of interest equalisation scheme

The commerce ministry is likely to seek further extension of the interest equalisation scheme in the forthcoming Budget on pre- and post-shipment rupee export credit for another five years to promote the country's outbound shipments, an official said. The scheme ended on December 31 last year. The scheme helps exporters from identified sectors and all MSME manufacturer exporters to avail of rupee export credit at competitive rates at a time when the global economy is facing headwinds. Exporters get subsidies under the Interest Equalisation Scheme for pre- and post-shipment rupee export credit.

Departments of commerce, revenue, BCAS formulating SOP for e-commerce export hubs

India, Oman hold fifth round of talks for proposed free trade agreement

India and Oman are holding the fifth round of talks for a proposed free trade agreement here to boost bilateral economic ties, an official said on Tuesday. The two-day talks started on January 13, the official said. The negotiations for the agreement, officially dubbed as Comprehensive Economic Partnership Agreement (CEPA), formally began in November 2023. Oman is the third largest export destination among the Gulf Cooperation Council (GCC) countries. According to the think tank GTRI (Global Trade Research Institute), Indian goods worth \$ 3.7 billion like gasoline, iron and steel, electronics, and machinery will get a significant boost in Oman, once both sides reach a comprehensive free trade agreement.

A case for completely doing away with the basic customs duty has been made to the finance ministry for inclusion in Budget 2025-26," a senior government official told ET.

Soyabean, sunflower oils push India's edible oil imports up by 13%

A significant jump in the imports of soyabean oil and sunflower oil has led India to register 13.03 per cent growth in edible oils imports in the first two months of the oil year 2024-25 (November-October). According to the data compiled by the Solvent Extractors' Association of India (SEA), the country imported 27.25 lakh tonnes (It) of edible oils during the first two months of the oil year 2024-25 against 24.55 lt last year.
