**NOTE :**

Fourth Meeting to review the COVID-19 situation in Ahmedabad Municipal Corporation area and to decide the strategy for various measures to be taken in the next few days was held today i.e. on 11.5.2020 at 12.00 hrs at SRFDC House, Ahmedabad. Municipal Commissioner, Ahmedabad Shri Mukesh Kumar, IAS and Deputy Municipal Commissioners of various Zones, Health, Medical Officer of Health etc. participated in the Meeting. After detailed deliberations on various issues, following decisions were taken:

1. As part of preparatory strategy post lock-down period, all the major retail and home delivery agencies like D-Mart, Osia Hypermart, Big Basket, Big Bazar, Zomato, Swiggy etc. have been contacted and asked to get 100% screening of their delivery staff. As an abundant caution to **prevent corona spread through currency notes**, it has been made mandatory/compulsory to accept digital mode of payments through Unified Payment Interface (UPI) and other platforms. **Thus home delivery has been made mandatorily cashless (COD-Cash On Delivery not permissible from 15<sup>th</sup> May).**


## 2. Home Delivery Protocol:

- i) Health card by A.M.C. valid for 7 days. To be renewed from time to time.
- ii) No delivery boy to be enlisted from Containment Area.
- iii) Delivery boy will have to use hand gloves, sanitation cap and sanitizer and follow social distancing norms.
- iv) Only cashless payment mode to be accepted. No Cash On Delivery (COD).
- v) **Every delivery staff will compulsorily have to download Arogya Setu App on their mobiles.**

3. For around 17000 Retail shops of vegetables, fruits, milk, groceries etc., A.M.C. is making 100 teams, who will go to each shop to get online payment App installed in mobile phones, give technical support and popularize payment through Unified Payment Interface (UPI). This would prevent infection transmission through currency notes (it is found that Corona Virus can survive on paper for many days). Additional expert man power may be hired by A.M.C. for this purpose.

Separate guidelines are being notified for retail sales from 15<sup>th</sup> May onwards.

Above decisions shall be implemented immediately.
